

**Murray Report**

Pursuant to the Senate Order on departmental and agency contracts the following table sets out contracts entered into by the DEPARTMENT OF FOREIGN AFFAIRS AND TRADE which provide for a consideration to the value of \$100 000 or more and which:

- a. have not been fully performed as at 31 December 2006, or;
- b. which have been entered into during the 12 months prior to 31 December 2006.

Unless otherwise specified, the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract. Most of the confidentiality clauses do not bind the Commonwealth from disclosing information, which it may be required to do for public accountability reasons, including a request for information by parliament or a parliamentary committee.

The reasons for including such clauses include:

- ordinary commercial prudence that requires protection of trade secrets, proprietary information and the like; and/or
- protection of other Commonwealth material and personal information; and/or
- contracts signed under previous contracting practice wherein elements of the contract or the entire contract were accepted as being 'commercial-in-confidence'. Contracting policy has since changed.

The "Whether contract contains 'Other requirements of confidentiality' (Y/N)" column has been left blank for all contracts. The column will only be populated where the contract contains a provision that is not captured by the overarching statement above. The detail will then be given in the reasons column. The reasons column will be used where either of the "Whether contract contains provisions requiring the parties to maintain confidentiality of any of its provisions (Y/N)" or the "Whether contract contains 'Other requirements of confidentiality' (Y/N)" has been populated with 'Y'.

The Privacy Act 1988 and other statutory secrecy provisions apply to departmental contracts.

"Amount of Consideration" is the estimated total contract value including any options to extend.
