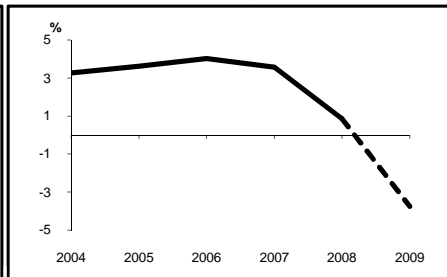

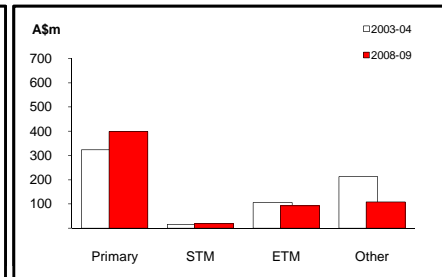
Australia's merchandise trade with Spain
