

**AMENDMENT 1 OF THE  
EXCHANGE OF LETTERS UNDER THE PARTNERSHIP FRAMEWORK 2009 – 2013  
BETWEEN THE WORLD HEALTH ORGANISATION (WHO) REPRESENTED BY  
THE INDONESIA REGIONAL OFFICE/COUNTRY OFFICE AND THE  
COMMONWEALTH OF AUSTRALIA REPRESENTED BY THE AUSTRALIAN  
AGENCY FOR INTERNATIONAL DEVELOPMENT (AUSAID) ON ACTIVITIES IN  
SUPPORT OF PUBLIC HEALTH IN THE INDONESIA REGION**

**AUSAID AGREEMENT NUMBER: 59143**

1. On 7 June 2011, The Commonwealth of Australia (Represented by the Australian Agency for International Development - AusAID) and World Health Organization - WHO ("the Parties") entered into Agreement 59143 through Exchange of Letter. ("the Agreement").
2. The Parties have now agreed to amend the Agreement as set out below:

Paragraph 3	<p>Delete existing Paragraph 3 and replace with new Paragraph 3 as follows:</p> <p>“ 3. AusAID offers to provide WHO Country Office with a contribution for the implementation of the activity described in the “Program Design Document” of January 2011 (attached to the existing EoL), proposal of additional activities of March 2012 (refer to Attachment 1 to this amendment), and any amendments agreed in writing by AusAID.”</p>															
Paragraph 4	<p>Delete existing Paragraph 4 and replace with new Paragraph 4 as follows:</p> <p>“4. The contribution for all components as described in the Program Design Document (attached to the existing EoL) and proposal of additional activities (refer to Attachment 1 to this amendment) is AUD4,295,000. 4. All other paragraphs and attachments to the Exchange of Letter remain unchanged and in full force.
