

**AMENDMENT 2 TO THE
ALL CHILDREN READING: A GRAND CHALLENGE FOR DEVELOPMENT
MEMORANDUM OF UNDERSTANDING (MOU) NUMBER 61320
AMONG THE UNITED STATES AGENCY FOR INTERNATIONAL DEVELOPMENT
(USAID), WORLD VISION, INC. (U.S.), WORLD VISION AUSTRALIA, AND THE
COMMONWEALTH OF AUSTRALIA AS REPRESENTED BY THE DEPARTMENT OF
FOREIGN AFFAIRS AND TRADE (DFAT)
(COLLECTIVELY "THE FOUNDING PARTNERS")**

1. On 18 November 2011 the Commonwealth of Australia, USAID, World Vision, Inc. and World Vision Australia ("the Parties") entered into a Memorandum of Understanding ("the MOU") in writing for the funding of the Activity described in MOU number 61320.
2. The MOU was amended in writing on 27 May 2014.
3. The Parties have now agreed to amend the MOU as set out below:

Paragraph XII - Effective Date,	Delete existing Paragraph XIII and replace with new Paragraph XIII as follows:

Duration, Amendment, and Termination	Activities under the MOU may commence once signed by the Founding Partners and are expected to continue through 30 September 2017. However, the Founding Partners may decide, in writing, to extend or shorten this period. In addition, this MOU may be modified in writing by mutual agreement of the Founding Partners. A Founding Partner may terminate its participation under this MOU at any time but should endeavor to provide at least 30 days' written notice to the other Founding Partners.
