RECITALS:

- A. On 18 February 2011 the Commonwealth and the Organisation entered into **Grant**Agreement Deed 58017 for the funding of the Activity described in the Agreement.
- B. The parties have now agreed to alter the Grant Agreement Deed as set out in this Deed.
