On behalf of Herbalife Nutrition Australia & New Zealand, we are pleased to hear that Australia and the United Kingdom (UK) are entering negotiations on a free trade agreement (FTA), which we strongly believe would be a boon to the economies and citizens of both countries.

Currently, Herbalife Nutrition is sourcing raw materials from New Zealand into our worldwide product supply chain, resulting in gains for New Zealand's dairy industry. Currently, we are looking at ways in which we can provide raw materials to our global supply chain from Australia. With the finalization of the Australia-UK FTA, we will see an even greater impetus in sourcing raw materials from Australia for use in our global supply chain.

In closing, on behalf of Herbalife Nutrition Australia & New Zealand, we lend our full-fledged support and encouragement for completion of the Australia-UK FTA.
