Dear Minister

In connection with the signing on 4 February 2016 of the Trans-Pacific Partnership Agreement (the "TPP Agreement"), I have the honour to confirm the following agreement reached between the Government of Australia and the Government of Chile during the course of negotiations of the TPP Agreement, regarding applicable government procurement thresholds for the purposes of Chapter 15 (Government Procurement) of the TPP Agreement and for the purposes of Chapter 15 (Government Procurement) of the Australia-Chile Free Trade Agreement (ACIFTA).

Australia and Chile agree that both for the purposes of Chapter 15 of the TPP Agreement and for the purposes of Chapter 15 of ACIFTA, and notwithstanding Section 8 of Annex 15-A of ACIFTA, the only applicable thresholds relevant to the definition of "covered procurement" applied by Australia shall be those specified in Australia's Schedule to Chapter 15 of the TPP Agreement, as adjusted from time to time in accordance with that Schedule.

I have the further honour to propose that this letter and your letter of confirmation in reply shall constitute an agreement between the Government of Australia and the Government of Chile, which shall enter into force on the first date on which the TPP Agreement is in force for both Australia and Chile.
