## Recognising animal welfare under an Australia-India Comprehensive Economic Cooperation Agreement

I would like to officially register RSPCA Australia's interest in the Australia–India Comprehensive Economic Cooperation Agreement (CECA negotiations). These negotiations present a significant opportunity for the Australian Government to demonstrate its commitment to high animal welfare standards and sustainable development practices.

Animal welfare is a critical component of sustainable development, having implications for all three pillars of sustainability – economic, social and environmental. This should be recognised in any trade agreement that Australia is party to. Australia is well placed to be an international leader in animal welfare practices and should seek to capitalise on this comparative advantage and market opportunity.

Animal welfare has been recognised in Australia's recent trade agreements with the United Kingdom (the Australia–UK Free Trade Agreement) and with the United Arab Emirates (the Australia–UAE Comprehensive Economic Partnership Agreement). RSPCA Australia has also advocated for the recognition of animal welfare as part of negotiations on the Australia–European Union Free Trade Agreement.

In addition, we are aware that India and the United Kingdom have recognised animal welfare in their Comprehensive Economic and Trade Agreement, signed on 24 July 2025. A range of animal welfare provisions are included in this agreement under Article 6.12. These include:

- recognition of the connection between the improved health of farmed animals and their welfare
- recognition that the protection and improvement of animal welfare may be an interest in the context of each Party's trade objectives
- a commitment to cooperation in the field of animal welfare, including the exchange of information, expertise and experience
- a commitment to cooperation on the World Organisation for Animal Health (WOAH) animal welfare standards.

At a minimum, we would urge the Australian Government to advocate for similar provisions in the Australia–India CECA.
