Dear Ambassador Froman

I have the honour to acknowledge receipt of your letter of 4 February 2016, which reads as follows:

“In the course of negotiations regarding the Trans-Pacific Partnership Agreement (TPP Agreement) signed this day, the delegations of the Government of Australia (Australia) and the Government of the United States of America (United States) discussed the importance of privacy protections to a healthy digital environment. In connection with the signing on this date of the TPP Agreement, I have the honor to confirm the following understandings reached between the United States and Australia regarding this issue:

Should the United States undertake any relevant additional commitments to those in the TPP Agreement with respect to the treatment of personal information of foreign nationals in another free trade agreement, it shall extend any such commitments to Australia. The United States will also endeavor to apply extensions of privacy protections with respect to personal information of foreign nationals held by the United States Government to Australian citizens and permanent residents.

I have the further honor to propose that this letter and your letter in reply confirming these mutual understandings constitute a Memorandum of Understanding between the United States and Australia which will come into effect on the date of signature of your letter of confirmation.”

I have the honour to confirm that the above reflects the mutual understandings reached between the Government of Australia and the Government of the United States of America during the course of negotiations on the TPP Agreement, and that your letter and this letter in reply constitute a Memorandum of Understanding between the Government of Australia and the Government of the United States of America.
