Dear Sir/Madam

The AHEIA is a non-governmental and not-for-profit organisation, with a primary focus on advocacy to enhance the trade of horticultural produce in and out of Australia. The AHEIA has been the peak industry body representing exporters and importers of horticultural produce in Australia since 1987.

India is a market that offers huge potential for growth of Australian horticultural products. Australian fresh products permitted into India are - Apples, Stone fruit (including cherries), Blueberries, Dates, Citrus, Table Grapes, Kiwifruit, Pears and the only vegetables permitted to be exported are the Alliums (Chives, Garlic, Onions, Leeks and Shallots).

Our members feel that they are operating at a disadvantage compared to other countries who appear to be gaining more favourable terms of access.

Currently, volumes exported from Australia are much lower than they could be with our members voicing their concerns relating to the high tariffs charged on products on arrival in India. Our industry believes this is the major obstacle hindering increased export volumes.

Australia's cost of production of fresh produce is high compared to some of our competitors, due in part to our growing, labour and transport costs. Australia exports a superior quality product grown under safe conditions, but we still must be competitive with other countries in the world. When India adds huge tariffs to our products, our market potential is limited.

Currently, the Central Board of Excise and Customs of India shows tariffs on products as listed below:
