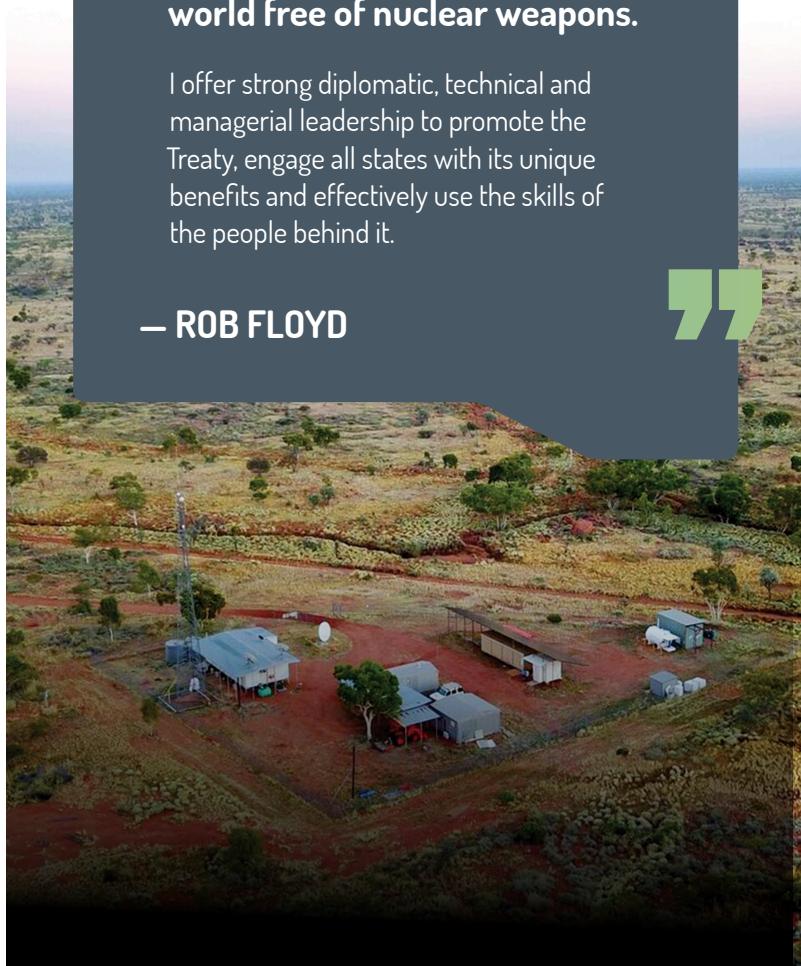

AUSTRALIA HAS A LONG AND ACTIVE COMMITMENT TO ESTABLISHING A BAN ON NUCLEAR WEAPONS TESTS AND NOW NOMINATES **DR ROB FLOYD**, A SCIENTIST WITH EXTENSIVE LEADERSHIP, MANAGEMENT AND DIPLOMATIC EXPERIENCE, TO LEAD THE CTBTO – THE FIRST FROM THE INDO-PACIFIC REGION.

CURRENT POSITION

Dr Floyd is the Director-General of the Australian Safeguards and Non-Proliferation Office (ASNO), which implements the CTBT, Australia's NPT safeguards and physical security commitments, the Chemical Weapons Convention, the South Pacific Nuclear Free Zone Treaty and 25 Bilateral Nuclear Cooperation Agreements.

Other leadership roles

- » Provision of technical advice on the sensitive matter of safeguards implementation to the DG of the IAEA as chair of SAGSI, since 2012
- » Lead development of inspection concepts in the International Partnership for Nuclear Disarmament Verification as a co-chair, since 2015
- » Guide the preparatory process for the inaugural review of the Convention on the Physical Protection of Nuclear Material as amended

AUSTRALIA'S COMMITMENT TO THE CTBT

Australia brought the CTBT text into the UN General Assembly for endorsement in 1996.

Australia has advocated at a high political level since the 1980s for a ban on nuclear weapons tests and has continued to support the Treaty and the CTBTO, co-chairing the Friends of the CTBT Ministerial process and leading the annual UNGA CTBT resolution. Australian experts actively engage in the development of all aspects of the verification regime.

As Director-General of ASNO, Dr Floyd oversees operation of Australia's 23 IMS facilities - the third largest number of any country.
