Summary

Prime Minister Morrison will make announcements tomorrow, Tuesday 16 October, in relation to Australia's Middle East policy. Grateful posts undertake action as requested.

Prime Minister Morrison will make announcements tomorrow, Tuesday 16 October (Canberra time), in relation to Australia's Middle East policy. These are expected to appear in morning media.

2. The announcement follows careful consideration by the Prime Minister, in consultation with Ministers, on a number of important issues affecting Australia's interests in the Middle East, as follows:

Australia's diplomatic presence in Israel

The Prime Minister will announce he has found the arguments put forward by Australia's former Ambassador to Israel [Dave Sharma] - that we should consider recognising

Jerusalem as the capital of Israel, without prejudice to its final boundaries, while acknowledging East Jerusalem as the expected capital of a future Palestinian state - persuasive. The Prime Minister will also say that we should be open to examining the merits of moving Australia's embassy to Jerusalem - in the context of our support for a two-state solution. Any decision will be subject to a rigorous assessment of our broader national interests.

It is important to note that Australia remains firmly committed to a two-state solution that allows Israel and a future Palestinian state to exist side-by-side, in peace and security, within internationally recognised borders. Talking points are attached. Broader whole-of-government talking points to follow in due course.

8. All other posts are asked to discuss with host governments as appropriate, following the announcement and drawing on the attached talking points. All posts are requested to report as a matter of priority on international reactions to the Prime Minister's announcements. For all posts: if any inquiries are received ahead of a formal announcement, you should draw on the attached talking points.

9. All posts are requested to closely monitor the security environment and threat levels and to take appropriate security precautions, s 33(a)(i), s 37(1)(c)

- Prime Minister will be making an announcement in relation to Australia's Middle East policy on Tuesday, 16 October
 - this is under embargo and we ask that you do not disclose to any other parties prior to an announcement by the Prime Minister.
- The announcement follows careful consideration by the Prime Minister, in consultation with Ministers, on a number of important issues affecting Australia's interests in the Middle East.
- Important to emphasise no change in Australia's policy in support of peace and stability in the Middle East.
- Government remains firmly committed to the Middle East Peace Process
 - o and to a two-state solution that allows Israel and a future Palestinian state to exist side-by-side, in peace and security, within internationally recognised borders.
- We will continue to encourage both sides to continue dialogue and negotiations towards a peaceful settlement.
