I just have been looking at the DFAT disclosure log and have some questions regarding three of them. There appears to be a lot of questions, but they are really "clarifications" to ensure what I write is accurate. I can just write from the documents. The Opposition claims Mr Rudd is using the embassy as a "party palace". If Mr Rudd would like to respond to that statement, I will include his reply.

1. FOI Reference number LEX11178

The documents include several invoices pertaining to the inaugural embassy of Australia Awards Gala 23 January 2024 event. My questions are as follows:

Q 1: Invoice No. EMBAUS20241 is to RGI Events for an amount \$185,034. Was this entire paid for by taxpayers? Was any part of it covered by sponsors? If the latter, what is the breakdown? What services did RGI Events provide?

DFAT - RELEASED UNDER THE FREEDOM OF INFORMATION ACT 1982 LEX 11517 - Document 1

Q 2: There is a receipt for a flight from LAX to DCA for AUD\$590.30. Was this covered by taxpayers? Who was the passenger on the trip?

Q 3: Another tax invoice is for \$10,560 AUD for the "Emcee". A separate tax invoice for the "Emcee" was for \$15,840. A press release by DFAT about the gala said the event included "Channel 10 Australia presenter Narelda Jacobs as Emcee". The two amounts total \$26,400. **Was this amount covered by the taxpayer?**

Q4: How many guests attended the gala? The media relaase also says how the "Embassy of Australia's Season of Opening Events was generously supported by:

Presenting Partner: Pratt Industries; Platinum Sponsor: Rio Tinto; Gold Sponsor: BHP; Silver Sponsor: Amazon Web Services; Travel Partner: Qantas Airways; Meat and Livestock Australia, Tourism Australia, and Bundaberg. **What did the sponsors contribute to the event?**

2. FOI Reference number LEX11175

... documents and invoices related to the function hosted in the Residence of the Ambassador of Australia to the United States in Washington D.C. to mark the visit of ACTU secretary Sally McManus in May 2024."

Q 1: There is an invoice for a Plated Dinner & Cocktail Reception on 5.20.2024 for \$1,100 and \$540, totalling \$1640. A separate invoice is to wine, totalling \$584. Was this covered by the taxpayer?

Q 2: Another invoice is for \$2,080 to Nellys Professional Staff. The invoice shows the amount is for 12 "Aus Res Butler Service". **Can I confirm the above events involved 12 butlers? Was there sole role to serve food?**

3. FOI Reference number LEX10891

Q: The documents contain emails relating to the purchase of a electric barbecue costing \$9,260.

An email from the supplier states: I am reaching out as I would like to enquire about purchasing a BBQ from your website for delivery to the

Australian Embassy in Washington DC. Q: Who paid for the BBQ? Is it for personal use or for functions and/or both? I note that it is for the L2 terrace. Were any modifications required is sprinkler adjustments etc to accommodate the BBQ? Has it been used!

The Australian Embassy in Washington DC has, under all Ambassadors, used public diplomacy events to promote and build a better understanding of Australia and Australian Government policies in the United States. Hosting events that draw attendance from diverse, influential stakeholders is a core part of diplomacy and advancing Australia's policies, priorities and interests internationally.

In the 2023-24 financial year, the Embassy received USD775,000 in sponsorship from a number of companies for a series of events to mark the opening of the new embassy. A number of other organisations provided in-kind support.

All of the costs associated with the 23 January 2024 Australia Awards Gala, attended by around 200 guests drawn from Congress, the White House, the State Department, Pentagon, and business and industry leaders from the United States and Australia, were paid for using this sponsorship and support.

ACTU Secretary Sally McManus was not a guest at the evening reception on 20 May 2024. This event involved the American Federation of Labor and Congress of Industrial Organizations, which has been held by the Embassy over a number of years. It is common practice for embassies to host events involving the business community or labour organisations.

A BBQ at the Australian Embassy has been incorporated into the building's design since 2017, to service functions and events. Procurement of a commercial BBQ, which meets strict health and safety standards required under U.S. regulations, commenced in 2022. The BBQ was installed in July 2024, in accordance with government guidelines.

There appears to be a lot of questions, but they are really "clarifications" to ensure what I write is accurate. I can just write from the documents. The Opposition claims Mr Rudd is using the embassy as a "party palace". If Mr Rudd would like to respond to that statement, I will include his reply.

The documents include several invoices pertaining to the inaugural embassy of Australia Awards Gala 23 January 2024 event. My questions are as follows:

Q 1: Invoice No. EMBAUS20241 is to RGI Events for an amount \$185,034. Was this entire paid for by taxpayers? Was any part of it covered by sponsors? If the latter, what is the breakdown? What services did RGI Events provide?

Presenting Partner: Pratt Industries; Platinum Sponsor: Rio Tinto; Gold Sponsor: BHP; Silver Sponsor: Amazon Web Services; Travel Partner: Qantas Airways; Meat and Livestock Australia, Tourism Australia, and Bundaberg. **What did the sponsors contribute to the event?**

... documents and invoices related to the function hosted in the Residence of the Ambassador of Australia to the United States in Washington D.C. to mark the visit of ACTU secretary Sally McManus in May 2024."

Q 1: There is an invoice for a Plated Dinner & Cocktail Reception on 5.20.2024 for \$1,100 and \$540, totalling \$1640. A separate invoice is to wine, totalling \$584. Was this covered by the taxpayer?

Q 2: Another invoice is for \$2,080 to Nellys Professional Staff. The invoice shows the amount is for 12 "Aus Res Butler Service". **Can I confirm the above events involved 12 butlers? Was there sole role to serve food?**

Q: The documents contain emails relating to the purchase of a electric barbecue costing \$9,260.
