At this stage, we have pencilled in a lunch event between 12.00pm and 2.30pm AWST on 10 December, the day before the Australia India Women's One Day International game.

Objective:

On the eve of the Australia v India Women's One Day International, this event will highlight the role of sport as a platform to cultivate leadership and empower women and girls in Australia and India. DFAT's new International Gender Equality Strategy, set to be launched later this year, addresses economic empowerment, education, and inclusion – all themes that link to women's leadership and participation in sport.
