## **Summary**

On 15 January President Biden announced a ceasefire and hostage deal between Israel and Hamas based on the three-phased plan he outlined last May. Biden praised the work of his national security team and acknowledged they had been working closely with representatives of the Trump transition team. The White House was confident disputes in Israel's cabinet would not hold up the deal. President-elect Trump claimed credit for the outcome.

On 15 January President Biden, flanked by Vice President Harris and Secretary of State Blinken, addressed the nation to announce a ceasefire and hostage deal between Israel and Hamas.

- 2. Biden said the deal covered the three phases he outlined in his May 2024 ceasefire plan s 22(1)(a)(ii) .
- 3. Biden said he was "deeply satisfied" this day had come for the sake of the "innocent people in Gaza who suffered unimaginable devastation because of the war" and had "gone through hell". The people of Gaza could recover, rebuild and look to a future without Hamas in power.
- 4. Biden said the deal was reached because of the pressure Israel built on Hamas, backed by the US. He praised the "extraordinary team" of US diplomats, led by Blinken, who helped get the agreement done. In a statement announcing the agreement, Biden said it was the result "of dogged and painstaking American diplomacy".
- 5. In response to 16 January media reports that disputes within Israel's cabinet were holding up completion of the deal, White House spokesperson John Kirby told NBC the Administration was "confident that we'll be able to solve these last minute issues and get it moving". Blinken said at a press briefing on 16 January that he expected the ceasefire agreement to go into effect on Sunday.

## The Trump Factor

6. When asked by a reporter if he or Trump deserved the credit for the deal, Biden said "Is that a joke?" However, during his address, Biden did acknowledge his Administration and the incoming Trump team had been "speaking as one" during this latest round of negotiations.

This sentiment was echoed by Qatari Prime Minister Al Thani who, when announcing the ceasefire, said that "two US administrations working together...led to this moment."

7. In early January, Trump dispatched his incoming Middle East envoy, Steve Witkoff, to Doha to work with Biden's top Middle East adviser Brett McGurk to push for a deal. Trump repeatedly threatened severe consequences unless Hamas released the hostages before his inauguration s 22(1)(a)(ii) . Biden said the deal would have to be implemented by the incoming administration and his national security team would coordinate closely with the Trump team "to make sure we're all speaking with the same voice, cause that's what American presidents do".

MARGARET BRENNAN: We are joined now by Congressman Mike Waltz. He's the incoming national security adviser to president-elect Donald Trump.

Good to have you here.

REPRESENTATIVE MIKE WALTZ (R-Florida) (Incoming U.S. National Security Adviser): Good to be with you. Thanks.

MARGARET BRENNAN: I understand, just yesterday, you were meeting with the families of some of the hostages being held in Gaza, at least three Americans assessed to still be alive and in captivity.

One of them might not be released until phase two, when male soldiers are released and Israeli troops withdraw. Will the Trump team see this through to completion?

REPRESENTATIVE MIKE WALTZ: Well, remember, the terms of the deal that we finally have come to was inherited in many ways from the Biden administration.

So it was actually the Biden negotiators that were at the table, and the -- the other side was dealing with them, but kind of looking to us, particularly Steve Witkoff, President Trump's Middle East envoy.

And one of the things that we inherited was this framework of women, the elderly and the sick coming out first. The -- one of the Americans is an Israeli soldier. He -- that means he'll come out in the second phase, but we will get him out, period.

MARGARET BRENNAN: Edan Alexander.

REPRESENTATIVE MIKE WALTZ: And I -- Edan Alexander.

And I am convinced, Margaret, that this deal would have never happened had President Trump not been elected, the Trump effect, so to speak. And the families believe that. They were effusive in their thanks for him and the -- the TRUTH that he put out that put Hamas on notice that there will be consequences if they don't let our people go.

MARGARET BRENNAN: There is also obviously the party Israel here...

REPRESENTATIVE MIKE WALTZ: Yes.

MARGARET BRENNAN: ... that feels some pressure to get this done. One far right member of the Netanyahu government resigned. Another this morning said he will bring down the Netanyahu government if it does not return to fighting in a way that leads Israel to taking over the entire Gaza Strip.

Does Mr. Trump support annexation of the West Bank and Gaza?

REPRESENTATIVE MIKE WALTZ: Well -- excuse me -- very different things.

What we're talking about here is making sure that Hamas is destroyed as a terrorist organization. Hamas is no different than ISIS or al Qaeda or any of the worst of the worst that has so brutalized the Middle East over the years.

And what we have made clear to Bibi Netanyahu, to his government -- and I want the Israeli people to hear me loud and clear -- if Hamas reneges on this deal, if Hamas backs out, moves the goalposts, what have you, we will support Israel in doing what it has to do, number one, and, number two, Hamas will never govern Gaza.

That is completely unacceptable, because they've made their intention clear, which is to destroy Israel and to have future October 7's. So I understand the concern. But, at the end

of the day, Prime Minister Netanyahu supported this deal. He agreed we needed to get those hostages out.

And within the next 24 hours, we will see -- we will see three women coming out alive and hugging their families. And had we not entered this, these people would have died, Margaret. I mean, these conditions that they were in -- by the way, they've been held now longer than the hostages in 1979 in the Iranian hostage crisis.

MARGARET BRENNAN: Yes.

REPRESENTATIVE MIKE WALTZ: They were being brutalized, raped, tortured. It was horrific.

But now we're going to have a Reagan moment. We are going to have President Trump being sworn in as hostages are coming out alive, and that's something we should all celebrate.

24. The Department of State foreshadowed the announcement of a new arrangement to deliver food aid to Gaza was "steps away". State spokesperson Tammy Bruce gave few details about the new mechanism but referred to a "charitable foundation" that she said would be carrying out the plan. Bruce said, "I was hoping to introduce it today, but the foundation will be announcing this shortly". Based on a document shared with the aid groups and the media, among the options being considered by the US is for the recently-established Gaza Humanitarian Foundation to stand up four "Secure Distribution Sites", each built to serve 300,000 people. The sites would provide pre-packaged rations, hygiene kits and medical supplies that would distributed through tightly-controlled corridors. US Ambassador to Israel Mike Huckabee said today that Israel would not take part in the aid distribution itself and would not depend on there being a pause in fighting.

Trump announced the release on Truth Social and in a news conference on Monday. Alexander has been held by Hamas for over 550 days. Trump's Special Envoy for Hostage Response Adam Boehler was reportedly travelling to Israel with Alexander's parents to retrieve their son from Hamas' captivity. Prime Minister Netanyahu called to thank Trump for his efforts in securing the release. Alexander's family says that if his physical condition permits, he will meet with Trump while he is visiting the region this week.

#### IDF strikes in Gaza

On Tuesday 18 March at 0319 (1219 AEDT), Prime Minister Benjamin Netanyahu <u>announced</u> that the IDF was attacking Hamas targets throughout the Gaza strip. Various media sources are reporting that between 30 and 80 Palestinians have been killed.

The strikes followed a <u>statement</u> from Netanyahu instructing the IDF to take 'strong action against the Hamas terrorist organisation'. Netanyahu <u>added</u> that 'Israel will, from now on, act against Hamas with increasing military strength'.

Media is reporting that Hamas has accused Israel of overturning the ceasefire agreement.

GWO will continue to monitor and provide a Situation Report as new information becomes available.
