Talking Points

Headline Statements

- Australia urges an immediate return to a ceasefire in Gaza
 - o civilians must be protected and all hostages released
 - all parties must abide by international law and rapid, sustained and unimpeded aid must flow to those in desperate need.
- Australia will continue working with the international community towards a two-state solution
 - a Palestinian state and the State of Israel, living side by side in peace and security within internationally recognised borders.
- Australia joins international partners in calling on Israel to allow a full and immediate resumption of aid to Gaza
 - Palestinian civilians cannot pay the price of defeating Hamas
 - o a significant, unimpeded and sustained scale-up is required
 - and aid workers must be protected to enable their lifesaving work.
- As Prime Minister Albanese has said, Israel's blocking of aid to people in need in Gaza is completely unacceptable
 - the Israeli Government cannot allow the suffering to continue.
- Australia has committed over \$110m in humanitarian assistance to support civilians in Gaza and Lebanon since 7 October 2023.
- We have consistently opposed the expansion of military operations by Israel in Gaza
 - just as we have been clear that forced displacement of Palestinians from Gaza would breach international law.
- Australia remains unequivocal in our condemnation of Hamas' horrific attacks on 7 October 2023 and ongoing
 acts of terror; use of human shields; and use of civilian infrastructure to launch attacks on Israel
 - terrorist group Hamas must release all hostages immediately, unconditionally and with dignity

- Gaza must no longer be used as a platform for terrorism
 - there is no role for Hamas in the future governance of Gaza.
- Hamas must be defeated and dismantled but this cannot be without account for the protection and welfare of Palestinian civilians
 - protection of civilians is paramount and a requirement under international law
 - the right of self-defence is not unconstrained: force used in self-defence must be necessary to address the threat or use of force and it must be proportionate to the threat that is faced.
- Australia has coordinated with partners in condemning and applying sanctions against Hamas, Hizballah and others for their terrorism
 - we have also joined to condemn and apply sanctions on Israeli extremists for their violence against Palestinians.

Also on 19 May, Foreign Minister Wong joined a statement by over 20 countries – including the UK, France, Germany – pressing Israel to end its block on aid into Gaza. The statement called for an end to impediments to the UN rapidly delivering aid at scale, and emphasised that aid should not be used to advance military or political objectives (such as displacement).

On 26 May, Prime Minister Albanese said "Israel's actions are completely unacceptable. It is outrageous that there be a blockade of food and supplies to people who are in need in Gaza... and we find Israel's excuses and explanations completely untenable and without credibility. People are starving, and the idea that a democratic state withholds supply is an outrage... But states, which are democratic states, have a responsibility to behave in a way that is consistent with International Law and with humanitarian concerns."
