Dear Ms Templeman

Thank you for referring petition EN6173 regarding recognition of a Palestinian State.

The widespread human suffering we are witnessing in Gaza is completely unacceptable. This cannot continue. This war must end.

While Australia is not a central player to the conflict, we have a respected voice and we are using it to advocate for a ceasefire, the protection of civilians, increased humanitarian assistance and the release of hostages.

Australia continues to support the international community's response to the humanitarian catastrophe in Gaza. Since October, Australia has committed \$72.5 million to address urgent needs arising from the conflict in Gaza and the protracted refugee crisis in the region. This includes our commitment in June this year of \$10 million through the World Food Programme to help provide life-saving food assistance to civilians in Gaza at risk of famine. Australia also provides annual core funding of \$20.6 million for the United Nations Relief and Works Agency.

We are using our voice and our vote in international institutions and forums. In December, Australia voted with 152 countries for a ceasefire at the United Nations, and we support the ceasefire proposal endorsed by the UN Security Council in June this year. We want to see it fully implemented by both parties. Any delay will only see more lives lost.

I have pressed for a ceasefire, protection of civilians, humanitarian aid and the release of hostages through persistent and extensive engagement with foreign counterparts, including during my visit to the Middle East, as well as with partners in Europe, Canada, Japan, the UK, the US and in our region.

I have pressed the Netanyahu Government directly, as have Government officials in Canberra and in Israel. We continue to make clear Australia's objection to Israel's operation in Rafah and our expectation that Israel act in accordance with international humanitarian law. We have been clear with Israel that it must comply with the binding orders of the International Court of Justice, including to enable the provision of basic services and humanitarian assistance at scale. The Australian Government is denying anyone identified as an extremist settler a visa to travel to Australia.

We are pressing countries with influence over Hamas, to help secure the immediate and unconditional release of remaining hostages. We remain unequivocal in our condemnation of Hamas's horrific terror attacks of 7 October 2023.

We have adopted the most supportive position on recognition of any Australian government in history. Labor will recognise Palestine – we will do this when our act of recognition meaningfully contributes to a peace process. The grave situation that Palestinians face needs more than symbolism – Australia is working with other countries to make statehood a reality. The only way to achieve a lasting peace is a two-state solution.

In May, Australia supported expanded Palestinian rights to participate in UN forums and the General Assembly's aspiration for eventual Palestinian membership of the United Nations, consistent with a two-state solution. Alongside key partners, we are looking at how we can support reform of the Palestinian Authority so that it can deliver on the needs of the Palestinian people.

In support of a two-state solution, the Albanese Government strengthened Australia's opposition to Israeli settlements by affirming they are illegal under international law and a significant obstacle to peace. We remain deeply concerned by settler violence against Palestinians, which only serves to inflame tensions and undermine stability at this delicate time. The Australian Government will deny anyone identified as an extremist settler a visa to travel to Australia.

The Albanese Government also adopted the name of 'Occupied Palestinian Territories', consistent with the approach taken by key partners, including the UK, EU and New Zealand, as well as the United Nations and the broader international community. In addition, our Government reversed the Morrison Government's decision to recognise West Jerusalem as the capital of Israel, reaffirming Australia's longstanding and bipartisan position that Jerusalem is a final status issue to be resolved through negotiations.

This devastating crisis demonstrates the need for a political solution to the long running Israeli-Palestinian conflict.

Australia remains steadfast in our support for a two-state solution - a Palestinian state and the State of Israel, living side by side in peace and security within internationally recognised borders.
