Purpose: Santos requested the meeting to discuss:

- Bayu-Undan cessation of production and carbon, capture and storage (with Timor-Leste)
- Abu Dhabi National Oil Company subsidiary XRG's proposed takeover of Santos.
- Announcement of the Commonwealth Gas Market Review.

Key points

- Timor-Leste is a close partner and neighbour.
- The Australian Government remains committed to cooperating with Timor-Leste on the necessary legal and regulatory frameworks to facilitate the transboundary movement of CO2.
- Note Santos ceased gas production from Bayu-Undan (BU) gas field last month [June] and Timor-Leste's ambition to convert Bayu-Undan into a Carbon Capture Storage (CCS) project
 - welcome an update from Santos on the decommissioning of Bayu-Undan and plans for a CCS facility.
- Australia is committed to remaining a reliable supplier of LNG and low emissions energy to the region through the energy transition, as per the Future Gas Strategy [9 May 2024]
 - the current Gas Market Review aims to create a long-term stable regulatory environment
 - welcome Santos to make a submission to the Gas Market Review (consultation closing 15 August 2025)
- Commend Santos on commencing operations the Moomba CCS project
 - welcome views on progress.

If raised: XRG proposed takeover of Santos

- Treasury will lead the process of reviewing the proposed purchase of Santos by XRG
 - would not be appropriate to provide any commentary outside of that formal review process
 - the Government does not comment on its consideration of specific foreign investment proposals.

If raised: Commonwealth Gas Market Review

- Australia's commitment is to continue to seek to address any gas supply shortfalls without negatively impacting long-term LNG supply contracts.
- The Review is expected to be finalised in late 2025, which will then be considered by Government.
- The Government has made it clear that it will take into consideration existing commercial contracts and trade law, including approvals under current regulations, when looking at potential areas of reform.

Background

Santos' key operations include Barossa Gas Project (NT) and Gladstone LNG (QLD). Its Timor-Leste based Bayu-Undan field ceased gas production in June 2025. Santos is developing domestic gas projects in Narrabri (NSW) and Beetaloo (NT). Internationally, Santos is a joint venture partner in PNG LNG and operator of the Pikka Project on the North Shelf of Alaska, USA.

Santos' key CCS projects include its Moomba CCS facility in South Australia, the Reindeer CCS project (WA - under development) and its proposed conversion of Bayu-Undan into a CCS facility. Moomba CCS Project is a joint venture with Beach Energy. It is the second onshore CCS project in Australia (after Gorgon, WA). Under the former Government's Carbon Capture Use and Storage Development Fund (CCUS DF), Santos received \$15 million towards its Moomba CCS project. Since beginning storage operations in September

2024, Moomba has reached about half of its annual CO2 storage capacity of 1.7 million tonnes per annum. Moomba CCS is expected to avoid more CO2 emissions in four days than approximately 10,000 electric vehicles in one year.

Gas Market Review

The Commonwealth Gas Market Review (the Review) commenced on 1 July 2025 and will be jointly led by the Department of Climate Change, Energy, the Environment and Water and the Department of Industry, Science and Resources. The Review will consider the Australian Domestic Gas Security Mechanism (ADGSM), Gas Market Code (the Code), and the Heads of Agreement with East Coast LNG exporters (HoA). These mechanisms are all required to be reviewed in 2025, where reviewing them together will provide a more holistic approach to considering the current mechanisms and identifying new policy settings.

Dear Minister

On behalf of the Santos Board and staff, I wish to congratulate you on your re-appointment as Minister for Foreign Affairs.

Santos looks forward to working with you and your government to support Australia's ongoing growth and success. We welcome your government's support for the future role of gas as a vital contributor to the energy transition towards Net Zero Emissions, and note that Santos is targeting net zero scope 1 emissions from our operations by 2040.

Santos is proud of the positive contributions we are making through operations across Australia, including the Cooper Basin, the Surat Basin and Gladstone regions, Narrabri, the Timor Sea, Beetaloo Basin, and not least as the largest supplier of domestic gas to Western Australia. Santos actively participates in the development of our regional neighbours as partners in PNG LNG and as operator of Bayu Undan in the waters of Timor Leste. We are also developing petroleum assets in the North Shelf of Alaska, USA.

For 70 years, we have conducted safe and sustainable operations across Australia, and we are keen to build on our contributions to the communities and regional economies. Each year, we invest approximately \$2 billion in support of our operations, for example \$500 million each year in an ongoing well development program.

We welcome your Government's focus on building the productivity of the economy and believe energy has a critical role to play in delivering greater efficiency and output as we advance towards Net Zero Emissions. Santos stands ready to support domestic gas supply from its portfolio of local production. For example, Santos has already committed 100% of the future supply from the Narrabri field to Australian industry and consumers, which could be quickly delivered if current requests to reconsider past decisions are determined urgently.

Santos appreciates the Federal Government's commitment to support the future of the Whyalla steel facility. We would be pleased to work with your and the South Australian Government to deliver an emission-abated gas supply which could help achieve Green Steel objectives.

The IEA states that the challenge of GHG emissions reduction, especially from hard to abate industry sectors, can be significantly addressed by Carbon Capture and Storage. At Santos we believe that Australia can build a world class carbon management industry based on CCS. Stage 1 of our Moomba CCS facility is already sequestering carbon at an annual rate of 1.5 million tonnes of CO2e – saving more CO2 in four days than 10,000 electric vehicles in one year - and we are actively exploring storage basins in the North West of Western Australia, the Bonaparte Basin and Timor Sea. To deliver on the potential of CCS for Australia's Net Zero goals, we believe that a clear policy commitment to advance CCS with a federal framework similar to WA and to accelerate bilateral arrangements for transboundary movements of carbon with Timor Leste, Japan and Korea is necessary.

Santos is a participant in the Safeguard Mechanism, although we are concerned that the trading of carbon credits for emissions from within our operations should not be limited to the support of other companies subject to the Safeguard Mechanism. For example, future CCS projects will not have access to the open market of ACCUs to reflect their contribution to emissions reduction, diminishing the commercial value of that activity and making it less likely that the required investment in CCS will occur in Australia. Moreover the potential to utilise existing infrastructure for CCS at Bayu Undan could allow Timor Leste to access a fresh revenue stream if Carbon Credits could applied to this project.

We believe that the solutions to two of Australia's biggest challenges and opportunities today – delivering reliable energy while managing emissions - will best be found through collaboration and a shared understanding. I therefore would like to invite you to visit our field operations and / or one of our operations centres at your convenience and hope to meet with you soon over the coming months to discuss Santos' role in growing Australia's natural gas capability and regional security —creating more jobs, boosting export income, and supplying reliable, affordable gas, while building a scalable carbon management industry.
