

Support for young people viewing violent and distressing online content

eSafety is aware that distressing material is circulating online showing the fatal shooting at Utah Valley University, which occurred earlier this week.

Young people who encounter content like this online may be struggling to come to terms with what they have read and seen. It is normal for them to have questions or feel unsettled, and your support can make a big difference.

Online spaces should be safe for everyone. If a child sees violent or distressing material, it is important to check in and talk to them about the content they have seen. We also recommend that children use devices in open areas of the home, rather than in their bedroom, so you can be attuned to how they are coping and what they are engaging with online.

Here are some practical steps Australians can take if they come across this type of material online:

- Report it to the platform: Most major services have reporting tools for violent and graphic content. Using these tools means harmful material can be flagged and removed quickly.
- Report it to eSafety: Australians can lodge a complaint via esafety.gov.au.
- **Do not share the video:** Even if your intent is to raise awareness, reposting graphic material increases the risk of trauma and amplifies harm.

update you with the actions taken in response to the assassination of Charlie Kirk, and how the major platforms have responded. Attached is a StiRep prepared by \$47F(1) and overseeing our investigations division.

eSafety has received multiple complaints and issued two removal notices in relation to online material showing the fatal shooting at Utah Valley University on 10 September 2025. A number of these include reports school age children have accessed unedited video footage of the shooting via popular social media platforms without safety warnings or content labels to prevent users, including young people, from coming across it inadvertently.

At eSafety's request, the Classification Board has reviewed two especially graphic instances of the material and assessed it Refused Classification (RC), meaning it is outside generally accepted community standards and exceeds what can be included in the R 18+ and X 18+ ratings. Whilst this was happening, we investigated to see where this content was going viral and engaged with social media companies to alert them to the presence of this material on their platforms. This also served to remind them of their obligations under the

Online Safety Act of 2021 to remove such material and in the first instance, to apply sensitive content warnings or interstitials to prevent involuntary viewing of the graphic content.

Tik Tok has voluntarily removed the material and were taking efforts to prevent further posting of the content. Other platforms took measures such as applying age or content warnings but ultimately, eSafety issued removal notices to Meta and X, requiring them to geoblock the material for Australian users from the URLs we provided them. As of this evening, both notices had been complied with and the material was not accessible to Australian users on either platform. There are a lot of continued attempts to upload and circumvent the filters and blocks so we will continue to monitor for compliance.

In terms of our public information sharing, we have encouraged members of the public can report harmful material to the platform they see it on and directly to eSafety at esafety.gov.au, rather than to share it further, even if this to alert others to the danger.

We also updated our home page banner to link to guidance on dealing with violent and distressing content, including how to discuss with children. We did a blitz on socials and also sent out the attached EDM to parents, educators and carers.

As indicated, we will keep monitoring and given the highly politicised and emotional dialogue around this tragic event, we have holding lines we will be using reactively only.

Removal notices issued to Meta on 12 September 2025 and X on 13 September 2025 in relation to Class 1 content posted on both social media platforms depicting the fatal shooting of U.S. political commentator Charlie Kirk.

Background:

On **10 September 2025**, U.S. political commentator and influencer Charlie Kirk was fatally shot while speaking at a public event at Utah Valley University. Multiple videos capturing the incident have since circulated across social media platforms including Instagram, TikTok, Facebook, and X.

On **11 September 2025**, two URLs containing footage of the incident were submitted to the Classification Board for review. The content was subsequently rated Refused Classification (**RC**) due to its graphic nature.

The videos, which were found on TikTok, X, and Instagram, depict the shooting in explicit detail from two different angles. The platforms were notified and provided with the URLs, along with information indicating that the content was under investigation by the eSafety Commissioner following public complaints.

TikTok confirmed that the video in question had been removed and advised that proactive measures are being taken to identify and remove similar content in accordance with their Community Guidelines on shocking and graphic material. Investigations have verified that the content is no longer accessible on TikTok.

On **13 September 2025**, investigations confirmed that the content classified by the Board as RC(1)(b) meets the criteria for Class 1 material and is therefore subject to removal under Part 9 of the Online Safety Act (OSA). This content was verified as being accessible on the Meta and X platform. Following consultation with the Legal and ICE Branches, a formal letter (the **Letter**) was drafted to notify all relevant platforms of the Classification Board's recent RC determination. The letter will also serve to remind platforms of their obligations regarding the removal of Class 1 content under the OSA.

Current Position:

On 12 September 2025 a section **109 removal notice** was issued to Meta for the Class 1 content still available on Facebook and Instagram (**Meta notice**). The previously mentioned **Letter** was included with the removal notice to reinforce the Classification Board's determination and remind Meta of its obligations under the OSA.

eSafetyinvestigations

On 13 September 2025 investigators confirmed that Meta has complied with the removal notice and geo-blocked access to Australian users.

In relation to the content hosted on **X**, investigators confirmed that the content was still available after the **Letter** was issued. Subsequently a section 109 removal noticed was issued to X on 13 September 2025. This notice has been complied with on 14 **September 2025**, investigators confirming the Class 1 content is no longer able to be accessed by Australian users of the platform. This action concludes phase 1 of the planned IRC investigations.

Future Direction:

The investigation will include the following phases.

Phase 2 – Respond to any additional complaints about content relating to the fatal shooting of Kirk as per IRC standard practices. Commence own motion investigations as per s42 of the OSA with regard to the accessibility and availability of the content.

Phase 3 – In consolation with Legal and ICE Branches consider the use of SPN under Part 9 of the OSA. Conduct an assessment of the outcomes of the investigations and share these insights as required.

Next Sitrep:

As required.

The immediate aftermath of the fatal shooting of conservative political activist Charlie Kirk The Administration s 33(a)(iii) s 33(a)(iii) are in mourning and genuine shock, Trump and other conservative figures have expressed rage and accused "the left" of "terrorism", and claimed that Kirk is a "martyr" and "a casualty of war" (Elon Musk, Steve Bannon, Laura Loomer). Democrats have also reacted with shock and condemned the act of political violence.

2. The President, who was the first to announce Kirk's death, has ordered flags be flown at half mask until Sunday s 33(a)(iii)

Trump has said he will posthumously award him the Presidential Medal of Freedom, the US' highest civilian honour.

3. Vice President Vance, a close friend of Kirk's, posted s 33(a)(iii)

Kirk "didn't just help us win in 2024, he helped us staff the entire government". Vance has forgone his scheduled engagements in New York today where he was due to visit Ground Zero to mark the anniversary of 9/11 and has instead travelled to Utah to hold vigil with Kirk's wife Erika before escorting Kirk's body and family back to their home state Arizona on Air Force Twos 33(a)(iii)

4. Kirk s 33(a)(iii)

is credited for swaying a significant youth vote (especially young men) for Trumps 33(a)(iii)

He was close to Vance,
Donald Trump Jr, and a host of other key Administration and conservative figures, he
is described as being on a first name basis with "an entire generation of White House
officials[...] twenty- and thirtysomethings who came of political age in the era after [Trump]
first took office". Kirk was the founder and director of 'Turning Point USA' a conservative
youth political action organisation which organised campus events at universities to debate
issues and promote conservative values. He is a popular podcaster and had around 10 million
social media followers across various platforms. Those eulogising him today have
championed his focus on debate as a way to express political differencess 33(a)(iii)

5. The USA Travel Advice already contains appropriate warnings about gun violence. However we are tracking developments and will ensure the TA remains relevant.

What comes next?

6. A manhunt led by the FBI is underway in Utah to find Kirk's killer, they have released images of the shooter and set a \$100,000 reward for information leading to their capture. s 33(a)(iii)

Trump said last night that his Administration will "find each and every one of those who contributed to this atrocity, and to other political violence, including the organizations that fund it and support it."

- 7. Deputy Secretary of State Christopher Landau today announced on X that consular officers would investigate and take action against foreigners who "glorify hatred and violence" by posting on social media "praising, rationalizing, or making light" of Kirk's shooting. s 33(a)(iii)
- 8. Kirk's funeral which will be held in Pheonix, Arizona in the next week or so is expected to be attended by thousands of supporters and may attract anti-Trump protests. We would expect that President Trump, VP Vance and many senior Administration officials and political figures from across the spectrum will attend.

- Trump: "The Great, and even Legendary, Charlie Kirk, is dead. No one understood or had the Heart of the Youth in the United States of America better than Charlie. He was loved and admired by ALL, especially me, and now, he is no longer with us. Melania and my Sympathies go out to his beautiful wife Erika, and family. Charlie, we love you!"
- Vance: "Charlie Kirk was a true friend. The kind of guy you could say something to and know it would always stay with him. [...] because he was a true friend ,you could instinctively trust the people Charlie introduced you to. So much of the success we've had in this administration traces directly to Charlie's ability to organize and convene. He didn't just help us win in 2024, he helped us staff the entire government."
- Donald Trump Jnr: "Charlie wasn't just a friend he was like a little brother to me and to millions of people around the world he was a true inspiration. [...] This is an unimaginable loss. For me, for his family, for everyone who loved him, and for America."

13. Democrats:

- Gavin Newsom: "The attack on Charlie Kirk is disgusting, vile, and reprehensible. In the United States of America, we must reject political violence in EVERY form."
- Kamala Harris: "Political violence has no place in America. I condemn this act, and we all must work together to ensure this does not lead to more violence."
- Barak Obama: "We don't yet know what motivated the person who shot and killed Charlie Kirk, but this kind of despicable violence has no place in our democracy. Michelle and I will be praying for Charlie's family tonight, especially his wife Erika and their two young children."

14. MAGA and conservative commentariat:

- Elon Musk: "The Left is the party of murder".
- Laura Loomer: "Charlie Kirk wasn't even controversial. He was moderate. He was conservative but by no means controversial. Imagine who else the Left is going to hunt down and murder on the right if they wanted to kill a guy who said 'get married, have kids, there's 2 genders, vote for Trump." Everyone needs to be very careful in their public surroundings. The Trump administration needs to start arresting everyone on the Left who promotes violence. All of the Leftist groups that pay for these radical protests need to be prosecuted. Enough is enough. More people will be murdered if the Left isn't crushed with the power of the state."
- Benny Johnson: "Charlie Kirk is a martyr. And martyrs only become more powerful. We must all, in our own poor and inadequate ways, seek to carry on Charlie's mission."
- Steve Bannon: "Charlie Kirk gave his life for his country on the battlefield of political combat. They cut him down with an assassin's bullet. Let's be blunt. He was cut down with an assassin's bullet."
