3. Recipients of hospitality

The facilitation of personal contacts with well-informed and influential members of local and international communities will assist officers in:

- promoting Australia's interests and policies;
- obtaining information that will form the basis of future reporting; and/or

- achieving efficiencies in the operation of the post.

As a general principle, it follows that local contact for which representation is claimed should fit one of the categories above.

In addition to local contacts, eligible recipients of hospitality also include Australians listed in the following categories:

- members of Federal and State parliaments and Territory and local government authorities;
- prominent citizens, for example members of business, media, academic, cultural, sporting and other visiting dignitaries; and
- Australian public servants, including employees from other posts and mission staff.

Expenditure is admissible where functions are held to enable people listed in the above categories to meet host country nationals or nationals of other countries, or where they are required to assist with a representation function, or where their presence is in the operational interests of the mission's objectives.
