Summary

A UK newspaper has reported that former Australian prime minister Tony Abbott has been appointed as co-president of the UK's Board of Trade. There has been no official confirmation to date, including from Trade Secretary Liz Truss, the current President of the Board, s33(a)(iii) & s47E(d)

On 26 August, The Sun newspaper reported that UK Prime Minister Boris Johnson had appointed former Australian prime minister Tony Abbott as co-president of the UK Board of Trade.

2. The Board of Trade is an historic body, revitalised in 2017 by then-Trade Secretary Liam Fox after being dormant for many years. In its current iteration, the Board notionally meets quarterly (although the last meeting was in May 2019) s33(a)(iii)

Post understands that the Board of Trade in its current iteration consists of Trade Secretary Liz Truss and three other members of Cabinets33(a)(iii) & s47E(d)

Truss and the Department for International Trade have not commented on the Sun's report. The 3. Shadow Trade Secretary Emily Thornberry today published an incendiary attack on Abbott in the UK media (attached). The High Commissioner is considering the best manner in which to respond.
