

Important Tips to Remember

The extent to which we are able to assist varies from country to country with the size of the overseas post and the scope of available resources.

We will always do our best to help. However, it is essential that you notify the DFAT NSW State Office of proposed visits as early as possible so we can discuss the required level of assistance well before departure.

Where a NSW Government office exists in the destination country, that office would normally manage the visit, including identifying potential contacts and making appointments. Where such a trip involves NSW Government Ministers and/or Parliamentarians, it is still essential to contact the DFAT NSW State Office so we can alert our posts to the presence of the party in their consular regions. Visits by the Premier or the Governor will involve the DFAT Head of Mission and require a more advanced level of involvement.

What we can do for you

The DFAT NSW State Office can assist NSW Government Ministers and Parliamentarians travelling abroad by contacting Australia's overseas posts to:

- seek suggestions on suitable government and business contacts
- facilitate appointments with preferred interlocutors, particularly with high-level host country government representatives
- arrange in-country briefings on local conditions and Australia's bilateral relationships
- obtain advice on logistical issues such as appropriate accommodation, interpreters and ground transport where required
- obtain advice on suitable trip dates, to avoid holidays or clashes with competing visits from other Australian representatives and take advantage of local events

What do we need from you?

It is important to provide as much as possible of the following information to us at the earliest opportunity, including:

- details of the travelling delegation, including names and position titles
- the proposed travel itinerary including flight and accommodation details
- · an outline of the general objectives of the visit
- · the nature of any assistance requested
- if appointments are sought, the range of topics to be discussed and CVs of any parliamentarians

Travel Planning

Travel Advisories

The Australian Government operates an online travel advisory and consular assistance service that provides up-to-date information on destination countries - www.smartraveller.gov.au. If in any doubt, please contact the DFAT NSW State Office for clarification. We strongly recommend you check travel advisories for your destination country and register your travel details so DFAT can contact you in an emergency.

Passports

NSW Government ministers are entitled to a diplomatic passport. Other members of the NSW Parliament and accompanying officials are entitled to an official passport. The standard processing time for passport issue is ten working days. However, payment of a priority processing fee guarantees a passport will be issued in two working days following lodgement of the application at the Australian Passport Office. Health Issues

Check with your doctor regarding any necessary vaccinations or medication you may need prior to your departure. If you intend to take prescribed medication or paracetamol to certain countries, we strongly recommend you contact the relevant Embassy, High Commission or Consulate of the country you are visiting to check that your medication is legal. Contact details for all foreign missions in Australia are available at www.smartraveller.gov.au

Visas

NSW Government representatives may require a visa when travelling on a diplomatic or official passport. Visas should be arranged through a travel agent or directly with the relevant Embassy, High Commission or Consulate. Where a Third Person Note is required, please contact the NSW State Office for assistance. For visa purposes, passports generally need to be valid for at least six months from the date of arrival in the last country to be visited.
