Australia's Minister for Foreign Affairs has considered your application. Unfortunately, you are not eligible for certification under this visa policy. However, on 18 August 2021, the Australian Government announced that an initial 3,000 humanitarian places will be allocated to Afghan nationals within Australia's 13,750 annual program. Particular priority will be given to persecuted minorities, women and children, and those who have links to Australia.

We encourage you to investigate your options fully, including under this humanitarian stream. The Department of Home Affairs is responsible for the processing of visa applications and your name and contact has been forwarded to the Department.
