We are advised senior representatives from Adani recently met in Beijing with officials from the National Development and Reform Commission and other ministries in relation to their Carmichael project in the Galilee Basin in Central Queensland.

The Australian Government is strongly committed to the opening up of the Galilee Basin mineral province. Its development will be a major contributor to Australia's economy and to the energy security, economic and environmental aspirations of the Asia-Pacific region. The Adani Carmichael Project is widely recognised as the catalyst to unlock the development of the Galilee Basin - Australia's largest remaining untapped coal basin.

The Australian Government welcomed Adani's recent Final Investment Decision to proceed with the Carmichael Project. This followed the receipt of all necessary Queensland State Government and Australian Government environmental and mining approvals.

Further, the Australian Government recently facilitated the passage of new legislation through the Parliament to remove doubt about Indigenous Land Use agreements, such as the one Adani has with relevant Indigenous Australians affiliated to the project area.
