Talking Points

- The Australian Government strongly condemns the attack at the DusitD2 Hotel in Nairobi, Kenya on 15 January (local time)
 - o our heartfelt sympathies are with the families and loved ones of those affected.
- The Australian High Commission in Nairobi is making urgent inquiries of local authorities to determine whether any Australians were affected by the attack
 - o at this time, we are not aware of any Australians being affected.
- We have updated the travel advice for Kenya, to advise Australians to keep clear of the area and follow the instructions of local authorities
 - o the level of advice has not changed
 - we continue to advise Australians to exercise a high degree of caution in Kenya due to the high threat of terrorist attack.
- Australians who have concerns for the welfare of family and friends in the area should attempt to contact them directly.

Any use or disclosure of personal information about individuals and the incidents contained in this background should not be made public. To do so may constitute a breach of the Privacy Act 1988 (Cth).

Background

At approximately 1530 hrs on Tuesday 15 January local time (2330 hrs AEDT) an explosion followed by gunshots was heard at the DusitD2 Hotel complex in the Riverside area of Nairobi.

The hotel is approximately 700 metres from the Australian High Commission. Staff at the Australian High Commission reported gunshots being fired directly outside the building. All staff are safe and accounted for.

Open source media have reported that police are treating the incident as a terrorist attack. Al-Shabaab, a Somali-based militant group has reportedly claimed responsibility.

In September 2013, Al-Shabaab militants entered the Westgate shopping mall in Nairobi, killing 67 people. In 2015, the group killed 150 people at Garissa University.

Summary

A suspected terror attack at the Dusit Hotel and office compound in Nairobi, 700 metres from the Australian High Commission on Riverside Drive occurred on the afternoon of 15 January and the situation is still not contained. The attack included grenades and a suicide bomber. All Australian Government officials are safe. No Australians are understood to be among the fatalities or injured. However, Post will continue to monitor. s47E(d)

No further staffing assistance is required. The

mission will be closed today.

A suspected terror attack at the Dusit Hotel and office compound in Nairobi, 700 metres from the Australian High Commission on Riverside Drive occurred in the afternoon of 15 January and the situation is still not contained. The attack included up to six attackers (including a suicide bomber), a vehicle, and grenades.

- 2. All Australian High Commission staff (DFAT, Home Affairs, Austrade and ACIAR) and visiting Australian Government officials from the Department of Environment and Energy s22(1)(a)(ii) and the Attorney-General's Department s22(1)(a)(iii) are safe. The JLL Facilities Manager, s22(1)(a)(iii), who was staying at the Dusit but was not at the hotel at the time, is now staying at the HOM Residence.
- 3. The AHC activated the Crisis Action Plan immediately following confirmation that the explosions were related to an attack. s47E(d)
- 4. As the situation is not yet contained, the Australian High Commission will be closed today, 16 January. GWO have been advised and phone line switched to Canberra. Post has updated social media and website accordingly. s47E(d)
 - . No further staffing support is required at this time.
- 5. At this time, we have no report of Australian casualties but will continue to monitor. Post has checked with four major hospitals reported to have taken injured Avenue Hospital, Aga Khan, MP Shah and Nairobi Hospitals and the Red Cross which have all advised no Australian casualties are among those admitted, at this time.
- 6. Post LO Reports of fatalities indicate 13 dead of which 7 are foreigners. One British and one American confirmed among the dead.
- 7. Timeline and Details of Incident and AHC Response Actions

Summary

With an end to the security incident in Nairobi, Kenyan security efforts have now shifted to forensic analysis and follow-up operations. Post is aware of only three Australians directly involved in the incident who were all evacuated safely. The Australian High Commission will reopen on 17 January and resume normal operations.

At approximately 1520 hrs on 15 January 2019, five individuals commenced an attack on the Dusit Hotel complex in Nairobi approximately 250 metres from the Australian High Commission (AHC). The attackers included four gunmen and one suicide bomber. Over the following 19 hours, Kenyan security officers neutralised the attackers and rescued hundreds of individuals. The AHC was informed at 1028 hrs on 16 January that the incident was over. **\$47C**

- 2. All AHC staff were accounted for and evacuated safely \$47E(d)
- 3. Kenyan authorities are now conducting follow-up operations with reports of a number of arrests. A forensic analysis of the hotel site is being undertaken.

4. The AHC will resume normal operations on Thursday, 17 January. s47E(d)

6. At time of writing, there are no further indications of Australian deaths or injuries. Post is aware of only three Australians directly involved in the incident who were all evacuated

Summary

Following the cessation of security operations at the Dusit Hotel complex, Nairobi Post reopened for business on 17 January and is now operating normally. At present a total of 21 individuals are known to have been killed in the attack. Some media are reporting the death of an Australian citizen. Post is following up these reports as a priority. Post management is addressing staff welfare issues. The latest Al-Shabaab statement cited that this attack was in response to the US declaration of Jerusalem as the capital of Israel. s47E(d)

Following the cessation of security operations at the Dusit Hotel complex, Post reopened for business on 17 January and is now operating as per normal.

Casualties

- 3. As of 17 January, Kenyan authorities are now reporting 21 deaths resulting from the attack. This includes 16 Kenyan nationals, one UK citizen, one US citizen and three unidentified individuals of African descent. Included within the Kenyan figures is a police officer who succumbed to injuries received during the clearance operation. The Kenyan Red Cross is reporting 18 individuals are still unaccounted for. In addition, five attackers were killed in the operation
- 4. Some international media are reporting the death of an Australian citizen who had recently flown into Nairobi from Australia. Post is not aware of any Australians killed but is presently following up all leads, as a priority, including the possibility that one of the unidentified individuals is Australian. Post will revert as soon as we have any information.

Summary

Below is a press statement issued by the UNSC on 16 January 2019 regarding the 15 January terrorist attack in Nairobi. The Council paid tribute to Kenya's role in the fight against terrorism, particularly in the struggle against Al-Shabaab.

The members of the Security Council condemned in the strongest possible terms the terrorist attack in Nairobi on 15 January 2019 which caused numerous deaths and injuries.

The members of the Security Council expressed their deepest sympathy and condolences to the victims and their families, as well as to the people and Government of Kenya. The members of the Security Council wished a speedy recovery to those injured.

The members of the Security Council paid tribute to Kenya's role in the fight against terrorism particularly in its role in the African Union Mission in Somalia (AMISOM) in the struggle against Al-Shabaab.

The members of the Security Council reaffirmed that terrorism in all its forms and manifestations constitutes one of the most serious threats to international peace and security.

The members of the Security Council underlined the need to bring perpetrators, organizers, financiers and sponsors of these reprehensible acts of terrorism to justice and urged all States, in accordance with their obligations under international law and relevant Security Council resolutions, to cooperate actively with the Government of Kenya and all other relevant authorities in this regard.

The members of the Security Council reiterated that any acts of terrorism are criminal and unjustifiable, regardless of their motivation, wherever, whenever and by whomsoever committed.

The members of the Security Council reaffirmed the need for all States to combat by all means, in accordance with the Charter of the United Nations and other obligations under international law, including international human rights law, international refugee law and international humanitarian law, threats to international peace and security caused by terrorist attacks.

Background

At approximately 1530 hrs (local time) on Tuesday 15 January (2330 hrs AEDT) five terrorists commenced a coordinated attack at the DusitD2 Hotel complex in the Riverside area of Nairobi. A suicide bomber detonated an explosive device in the hotel and four gunmen opened fire and threw grenades at hotel guests, staff and members of the public.

Reports indicate that around 50 civilians in two groups were trapped in the hotel overnight and were rescued in a security forces operation launched at dawn on 16 January.

President Kenyatta announced later on the morning of 16 January that 'all the terrorists had been eliminated'. Kenyatta also said that 14 people had been killed in the attack, though consular partners believe that 15 people

lost their lives, including one UK and one US national, 11 Kenyans and two of unknown citizenship. Kenyatta said that more than 700 people had been evacuated from the complex by security forces. On 17 January, Kenyan authorities reported 21 deaths, including 16 Kenyans, one UK citizen, one US citizen and three unidentified individuals of African descent. The Kenyan Red Cross is reporting 18 individuals are still unaccounted for. In addition, five attackers were killed in the operation.

The hotel is located approximately 700 metres from the Australian High Commission (250 metres as the crow flies). High Commission staff heard the nearby gunshots and explosions. All staff and dependents have been accounted for. We are aware of three Australians who were evacuated safely from the hotel complex and the Australian High Commission has been in contact with them. The post activated its business continuity plan and was closed to the public on 16 January due to the nearby police operation, with urgent consular and passport assistance remaining available through telephones switched back to the Consular Emergency Centre in Canberra. The post reopened on 17 January and is operating as per normal.

With an end to the incident, Kenyan security efforts are focused on forensic analysis and follow-up operations.

Al-Shabaab, a Somali-based militant group, has claimed responsibility for the attack.

Subject: Personal Security Awareness Briefing Notes

Security threats

Terrorism linked to al-Shabaab/al-Qaeda is a long-standing threat in the region. The most significant attacks in Kenya include:

- The Dusit Hotel complex in Nairobi was attacked in January 2019 killing 21 people.
- 67 people were killed in the attack on Westgate shopping mall in September 2013, including an Australian citizen and a Canadian diplomat.
- The US embassy in Nairobi was attacked in 1998 (killing 300) and an Israeli hotel and airline were attacked in Mombasa in 2002.
- In the first half of 2014, Nairobi and Mombasa experienced regular small-scale grenade and IED attacks targeting markets, churches, buses, bus terminals and police stations.
- Over 100 Kenyans were killed in Lamu county in June-July 2014 in attacks by gunmen on villages, towns and buses.
- In November 2014, 64 Kenyans were killed in Mandera, northern Kenya in two attacks on a bus and a quarry in November by al-Shabaab linked militants.
- On 3 April 2015, an attack at Garissa University in North-Eastern Kenya killed 148 people and injured a number of others.
- On 15 September 2016, three females linked to ISIL fire bombed the central police station in Mombasa. All three were killed as a result of police intervention

- On October 15 October 2016, A GSU officer was stabbed by ISIL linked member outside of the US Embassy in Nairobi. The GSU officer shot and killed the ISIL terrorist.
- Since the beginning of May 2017, more than 60 people, mainly security officers, were killed in a series of attacks in Lamu, Mandera and Garissa counties.

The **crime** rate is very high, with pickpocketing, muggings and car jackings. Three Australians were killed in home invasions in Nairobi by armed attackers between November 2013 and June 2014. s47E(d)

Incidences of sexual assault are high. Groups of motorcyclists have been known to target pedestrians for bag-snatching and motorists for car jackings. Muggings in and around the central business district are becoming common place. Attempted car jackings against diplomatic vehicles is not unknown.

Major **politically motivated violence** broke out across Kenya following the disputed 2007 elections, killing over 1,000. The 2013 elections proceeded relatively peacefully, \$47C , with large numbers of unemployed youth and rising costs of living. The 2017 elections saw protests and demonstrations; some of which were violent and resulted in over 300 deaths.

Students regularly protest – while initially peaceful, these protests often turn violent as students throw rocks and engage in running battles with the police.

Kenyan roads are dangerous, with few street lights, poorly maintained vehicles \$47C

. Newspapers regularly contain details of traffic fatalities. The rate of road accidents is high.

Tribal violence in Kenya's north-eastern regions is frequent, largely caused by tension over cattle, water and pasture lands. Following extensive drought, there has been an increase in incursions by herders, and associated violence, onto private ranches and wildlife conservancies in central and northern Kenya since late 2016. The herders have often been armed and the incursions have resulted in violence against property, wildlife and, in some cases, landowners. A dual British/Kenyan landowner was killed on his property on 4 March 2017 and a Swiss national was shot on 23 April 2017.

The threat of **kidnapping** remains. An Italian citizen was kidnapped in December 2018 from Kilifi County, north of Mombasa. Previously four Norwegian aid workers were seized from Dadaab refugee camp in July 2012. There were several incidents in 2011: in October 2011, a French national was attacked and kidnapped from her beachfront residence on Manda Island (adjacent to Lamu Island) by an armed group. She later died in captivity. In September 2011, two British nationals were attacked at a resort in Kiwayu, north of Lamu: one was killed and the other kidnapped and held in captivity for six months.

Locations

Coastal areas from Lamu county (south of Pate Island) to Mombasa and outskirts are "**reconsider your need**" destinations, due to the risk of crime, terrorism, and IED attacks.

Kenya's border regions with Somalia, Ethiopia and South Sudan are "do not travel" destinations because of the extreme threat posed by kidnapping, terrorism and violent conflict. The "do not travel" area along the border with Somalia includes Mandera and Garissa counties, Wajir and east of Wajir and the area north of Pate Island in Lamu county, including Kiwayu and Kiunga.

The border region between Kenya and Somalia, including Lamu, continues to see numerous militant attacks including grenades and IED, most recently in two attacks in Lamu in August 2018.

Smartraveller and the AHC also emphasise care to be taken in the Nairobi suburbs of Buruburu, Eastleigh, Kasarani, Kibera, Mathare, Pangani, South B and South C due to the threat of extremist attacks and violent incidents.

Politically motivated violence

- Avoid all demonstrations and monitor the media. It is a good idea to keep some contingency supplies (food/water/torch/candles/first aid supplies/medication/toiletries/pet food) in your home, should you need to remain at home for an extended period during a security emergency.
- You should also keep a grab bag with items you will need in case you need to depart at short notice.
 These items would include passport, drivers licence, USD and KES cash, cheque book, mobile phone and charger, AHC contacts, change of clothes, medications, bottled water, torch, rain coat.
- Always keep the petrol tank in your car at least half full, and have cash available in case ATMs shut down.

Terrorism

- Exercise heightened security awareness and take extra care in public places and at public events. Be
 aware that possible terrorist targets include hotels, airports, shopping areas, markets, bars, sports bars
 and nightclubs (including venues broadcasting international sporting events), restaurants and cafes,
 tourist resorts, churches and other places frequented by foreigners.
- In the event of an Active Shooter situation remember to RUN HIDE ACT

 - we are not aware of any Australian casualties at this time, but are checking hospitals and with Kenyan authorities.
- Our travel advisory for Kenya has been updated to urge Australians to keep clear of the area and follow the instructions of local authorities
 - we continue to advise Australians to exercise a high degree of caution in Kenya due to the high threat of terrorist attack.
- Australians who have concerns for the welfare of family and friends in the area should attempt to contact them directly.

Background

Despite a claim by a minister late on 15 January that the area had been cleared, fighting continued in the morning of 16 January. Reports indicate that around 50 civilians in two groups were trapped in the hotel overnight and were rescued in a security forces operation launched at dawn.

President Kenyatta announced later on the morning of 16 January that 'all the terrorists had been eliminated'. Kenyatta also said that 14 people had been killed in the attack, though consular partners believe that 15 people lost their lives, including one UK and one US national, 11 Kenyans and two of unknown citizenship. Kenyatta said that more than 700 people had been evacuated from the complex by security forces.

There are no reports of any Australians among those killed and injured. Post continues to liaise with local authorities on Australian interests.

The hotel is located approximately 700 metres from the Australian High Commission (250 metres as the crow flies). High Commission staff heard the nearby gunshots and explosions. All staff and dependents have been accounted for. The post has activated its business continuity plan and was closed to the public on 16 January due to the nearby police operation, with urgent consular and passport assistance remaining available through telephones switched back to the Consular Emergency Centre in Canberra. The post will reopen on 17 January and resume normal operations.

With an end to the incident, Kenyan security efforts are focused on forensic analysis and follow-up operations.

Local media outlets are reporting the death of an Australian citizen (named as Marcus Rodriguez) who had recently flown to Nairobi from Australia. According to movement records, no Australian passport holder of that name is currently offshore. The Australian High Commission in Nairobi is working to verify the media reporting. We are aware of three Australians who were evacuated safely from the hotel complex and the Australian High Commission has been in contact with them.

The hotel is located approximately 700 metres from the Australian High Commission (250 metres as the crow flies). High Commission staff heard the nearby gunshots and explosions. All staff and dependents have been accounted for. The post has activated its business continuity plan and was closed to the public on 16 January due to the nearby police operation, with urgent consular and passport assistance remaining available through telephones switched back to the Consular Emergency Centre in Canberra.
