The United States [State Department Spokesperson, Ned Price] rejected the view that Israel's actions constitute apartheid. Germany also rejected the use of the term apartheid. The European Union [Peter Stano, Spokesperson for the EU's Diplomatic Service] noted that it gives "all the due attention" to the report "as we do in the case of all the other stakeholders or NGOs".
