Senior Leadership



The Honorable Kevin Rudd AC

President and CEO, Asia Society; President, Asia Society Policy Institute

Kevin Rudd became president and CEO of Asia Society in January 2021 and has been president of the Asia Society Policy Institute since January 2015. He served as Australia's 26th Prime Minister from 2007 to 2010, then as Foreign Minister from 2010 to 2012, before returning as Prime Minister in 2013.

As Prime Minister, Rudd led Australia's response during the Global Financial Crisis. Australia's fiscal response to the crisis was reviewed by the IMF as the most effective stimulus strategy of all member states. Australia was the only major advanced economy not to go into recession. Rudd is also internationally recognized as one of the founders of the G20, which drove the global response to the crisis and in 2009 helped prevent the crisis from spiraling into a second global depression.

As Prime Minister and Foreign Minister, Rudd was active in global and regional foreign policy leadership. He was a driving force in expanding the East Asia Summit (EAS) to include both the U.S. and Russia in 2010. He also initiated the concept of transforming the EAS into a wider Asia-Pacific community to help manage deep-rooted tensions in Asia by building over time the institutions and culture of common security in Asia. On climate change, Rudd ratified the Kyoto Protocol in 2007 and legislated in 2008 for a mandatory 20 percent renewable energy target for Australia. Rudd launched Australia's challenge in the International Court of Justice with the objective of stopping Japanese whaling in the Southern Ocean. Rudd drove Australia's successful bid for its current non-permanent seat on the United Nations Security Council and oversaw the near-doubling of Australia's foreign aid budget.

Rudd is Chair of the Board of the International Peace Institute. He is a member of the IMF Managing Director's External Advisory Group and the Global Leadership Council for Sanitation and Water for All. He is a Senior Fellow at Harvard University's John F. Kennedy School of Government, a Distinguished Fellow at Chatham House in London, a Distinguished Statesman with the Center for Strategic and International Studies in Washington DC, and a Distinguished Fellow at the Paulson Institute in Chicago. Rudd is a member of the Comprehensive Nuclear Test-Ban Treaty Organization's Group of Eminent Persons. He serves on the International Advisory Board of the Schwarzman Scholars program at Tsinghua University. Rudd is proficient in Mandarin Chinese. He remains actively engaged in indigenous reconciliation.

EXPLANATORY MEMORANDUM

Minute No. 464 of 2022 - Minister for Foreign Affairs.

Subject- *The Constitution*

Termination of Appointment and Commission of Appointment of Ambassador of Australia to the United States of America

The purpose of this instrument is to make a diplomatic appointment.

The power to appoint Australian diplomatic and consular representatives is exercisable by the Governor-General by virtue of Chapter II of the *Constitution* which provides, among other things, that the executive power of the Commonwealth is vested in the Queen (as defined in section 2 as extending to her heirs and successors) and is exercisable by the Governor-General.

The Minute recommends the termination of the appointment of The Hon Arthur Sinodinos AO as Ambassador of Australia to the United States of America, from a date to be determined by the Minister for Foreign Affairs, and the appointment of The Hon Kevin Michael Rudd AC as Ambassador of Australia to the United States of America subject to *agrément* being received from the United States of America. The granting of *agrément* by the receiving State for the person a sending State proposes to accredit as head of mission is a requirement of the *Vienna Convention on Diplomatic Relations*, to which Australia is a party. The *agrément* of the United States of America will be sought for this appointment. The Minute also seeks authority for the Minister for Foreign Affairs to determine the salary, allowances and other terms and conditions to apply to this appointment.

Mr Rudd is expected to take up his position in February 2023, succeeding Mr Sinodinos who has been Ambassador since 2020. s 22(1)(a)(ii)

Mr Rudd is currently President and CEO of the Asia Society and President of the Asia Society Policy Institute. He has previously served as Minister for Foreign Affairs (2010-2012); Prime Minister (2007-2010 and 06-09/2013); Leader, Federal Parliamentary Australian Labor Party (2006-2010); Leader of the Opposition (2006-2007); Shadow Minister for Foreign Affairs (2001-2006); Member of the House of Representatives for Griffith, Queensland (1998-2013); Senior China Consultant, KPMG Australia (1996-1998); Director-General, Queensland State Cabinet Office (1991-1995); Chief of Staff to Queensland Premier (1988-1991); and was a former diplomat (1981-1988), including postings to Stockholm and Beijing.

Mr Rudd holds a Bachelor of Arts (Hons) from the Australian National University (1980).

Mr Rudd is suitable for appointment as Ambassador for Australia to the United States of America by virtue of his prior experience and relevant background.





EXPLANATORY MEMORANDUM

Minute No. 464 of 2022 - Minister for Foreign Affairs

Subject- *The Constitution*

Termination of Appointment and Commission of Appointment of Ambassador of Australia to the United States of America

The purpose of this instrument is to make a diplomatic appointment.

The power to appoint Australian diplomatic and consular representatives is exercisable by the Governor-General by virtue of Chapter II of the *Constitution* which provides, among other things, that the executive power of the Commonwealth is vested in the Queen (as defined in section 2 as extending to her heirs and successors) and is exercisable by the Governor-General.

The Minute recommends the termination of the appointment of The Hon Arthur Sinodinos AO as Ambassador of Australia to the United States of America, from a date to be determined by the Minister for Foreign Affairs, and the appointment of The Hon Kevin Michael Rudd AC as Ambassador of Australia to the United States of America subject to *agrément* being received from the United States of America. The granting of *agrément* by the receiving State for the person a sending State proposes to accredit as head of mission is a requirement of the *Vienna Convention on Diplomatic Relations*, to which Australia is a party. The *agrément* of the United States of America will be sought for this appointment. The Minute also seeks authority for the Minister for Foreign Affairs to determine the salary, allowances and other terms and conditions to apply to this appointment.

Mr Rudd is expected to take up his position in February 2023, succeeding Mr Sinodinos who has been Ambassador since 2020. s 22(1)(a)(ii)

He has previously served as Minister for Foreign Affairs (2010-2012); Prime Minister (2007-2010 and 06-09/2013); Leader, Federal Parliamentary Australian Labor Party (2006-2010); Leader of the Opposition (2006-2007); Shadow Minister for Foreign Affairs (2001-2006); Member of the House of Representatives for Griffith, Queensland (1998-2013); Senior China Consultant, KPMG Australia (1996-1998); Director-General, Queensland State Cabinet Office (1991-1995); Chief of Staff to Queensland Premier (1988-1991); and was a former diplomat (1981-1988), including postings to Stockholm and Beijing.

Mr Rudd holds a Bachelor of Arts (Hons) from the Australian National University (1980).

Mr Rudd is suitable for appointment as Ambassador for Australia to the United States of America by virtue of his prior experience and relevant background.

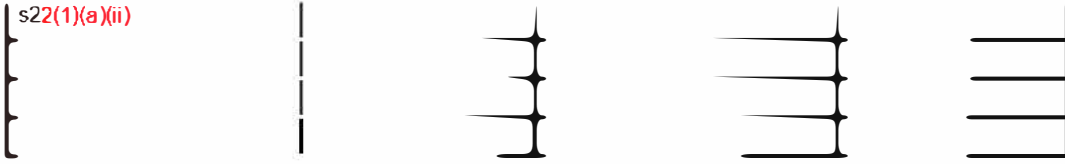
