Tender Schedule D: Financial Assessment (Financial viability of bidding organisation)

- See Part 1, Clause 8 of the RFT
- Financial Assessment for this RFT will be conducted differently to previous AusAID tenders.
- AusAID will appoint an independent financial assessor to analyse financial information.

1 November 2010	Final date for questions to AusAID on RFT (14 days before tender close)
8 November 2010	Final date for AusAID to issue addenda/respond to tenderer questions (7 days before tender close)
15 November 2010	RFT closing date
23 November 2010 (indicative)	TAP Shortlisting, assessment against Selection Criteria and like for like assessment
December 2010 (indicative)	Interviews and TAP recommendation
February 2011 (indicative)	If delegate approves TAP recommendation, negotiate contract
14 February 2011	Contract Start Date
