A prospective Australia-Israel Free Trade Agreement (FTA), properly and comprehensively designed, represents for Australia the opportunity to extend our nation's global engagement on a multi-tiered strategic basis. For Israel and Australia in combination, the leveraging of Australia's strategic engagement with our Indo Pacific neighbours will derive exponential mutual benefits in security, investment, enterprise and human capital.

Bipartisan imperative—enhanced mutual national interests

Bipartisan advocacy of the FTA through Australian and Israeli leaders shall create a significant added dimension to the bilateral relationship and a springboard for further initiatives.

- The Australia-Israel Economic Freeway, to which the FTA is integral, will provide a welcome layer of transparency for Australian citizens to experience first-hand benefits from the exponential creation of new economic space.
- At the heart of the Economic Freeway concept are liberated capital flows, free movement of people, two-way deals, research interchanges, widespread networking and expansion of relationships.
- Australian interests remain fundamentally unchanged to underwrite sustained prosperity for Australians, and to build on this security foundation by proactively engaging our front yard neighbours across the Indo Pacific and the wider world.
- These strategies must be pursued with likeminded partners because together they help optimise Australian national interests better than all other options.
- For example, as the world becomes increasingly exercised about the prospects in life sciences and the potential of biotechnology, it is well to remind ourselves that Australian excellence in world class scientific and medical research dates back over 100 years.
- The collaborative potential through combining Australian world class capabilities in life sciences with the preeminent capital market skills of Israel, is destined to become a high priority item on the Economic Freeway agenda.
- There is great potential to broaden the relationship between two of the great social experiments.
- Our shared challenge is sustained community cohesion.

ASPIRATIONAL, MODEL SOCIETIES

While no country or community withstands the withering scrutiny of perfection, aspirational model societies built upon democratic values, pluralism, principles of inclusion and universal adherence to the rule of law – of which Australia and Israel are examples – are again under serious and direct threat.

- Mutual trust is key to sustainable, systemic relationships.
- Time horizons need to be half centuries.
- Otherwise, misunderstandings with unforeseen consequences may occur.

There is a transcendent quality to innovative civil diplomacy which empowers individuals in different societies to promote greater cultural awareness and mutual understanding.

- The more practised we are as leaders in our professional lives, the more effective our voluntary efforts at mutual understanding can be.
- Civil leaders should provide the foundations of support to officialdom elected and appointed in confronting threats to the fabric of societies.
- Board Members of think tanks should have a mutual compact to publicly confront extremism in their countries, whatever their source and nature.
- As inaugural chairman of The Sydney Institute (1989-1993), I established this understanding with fellow Board Members.
- If left to officials to undertake this task alone, the risk can be too high.
- It is imperative to combat contemporary resurgence in anti-semitism, to engage and support moderate religious leaders, and confront outbreaks of left and right extremism.

The FTA would reinforce Israel's engagement throughout the Indo Pacific encompassing security, trade, investment and broader linkages.

- Australians should embrace this commitment.
- Our focus should not be about whether we are to be interlocked with Israel, but how we need to advance Australian and Israeli mutual interests by doing so.
- This is a leadership opportunity of significant moment.
- Leadership is about creating new space in the service of others.
- Israelis and Australians understand and embody this.
- Current and future generations of Australians and Israelis deserve no less from the management of this vital bilateral relationship.
