

Introduction

THE STATISTICAL SUMMARY IS PRODUCED ANNUALLY AND REPORTS ON AUSTRALIA'S INTERNATIONAL DEVELOPMENT COOPERATION WITH PARTNER COUNTRIES, MULTILATERAL ORGANISATIONS AND NON-GOVERNMENT ORGANISATIONS (NGOS).

The Australian Government's development cooperation program advances Australia's national interest by assisting developing countries to reduce poverty and achieve sustainable development. In 2003-2004, the program continued to help build a secure, prosperous and democratic Asia-Pacific region and contribute to global efforts to reduce poverty.

The Statistical Summary is produced annually and reports on Australia's international development cooperation with partner countries, multilateral organisations and nongovernment organisations (NGOs). It provides a range of statistics at the aggregate level, including geographical and sectoral information and forms of aid.

PROGRAM STRUCTURE

The development cooperation program is managed by AusAID. For the purposes of this publication the program is divided into three main sub-programs: Country and Regional, Global, and Departmental Expenditure. Funding is channelled through AusAID's Country and Regional and Global sub-programs, which are further broken down into a number of elements. The program structure is outlined in Appendix 1.

Global programs also contain activities that directly benefit partner countries. These include humanitarian and emergency assistance and funding through NGOs and multilateral organisations such as the World Bank, the Asian Development Bank and the United Nations Development Program (UNDP).

The full scope of Australia's international development cooperation includes expenditure administered by the Australian Centre for International Agricultural Research (ACIAR) and other Australian Commonwealth and State Government departments. Other Government departments (OGDs) are important partners in Australia's enhanced whole-of-government approach to development cooperation.

CONCEPTS AND DEFINITIONS

The concepts and definitions used in this publication are for the most part consistent with the Statistical Reporting Directives of the Development Assistance Committee (DAC) of the OECD and are defined in Appendix 2.

This publication reports on Official Development Assistance (ODA) and Official Aid (OA) on a cash basis. The DAC's List of Aid Recipients used to make this distinction is given in Appendix 3.

The sectoral breakdown of Australia's development cooperation is consistent with the DAC's sector code descriptions and is an indication of the primary sector benefiting from a particular activity. All activities, both AusAID and those managed by OGDs, have been classified according to their DAC sector.

This publication includes information on the ODA/GNI ratio. In 1998, the Australian Bureau of Statistics changed its method of calculating national income, from Gross National Product (GNP) to Gross National Income (GNI) in line with international standards. Generally, GNI figures are slightly higher than corresponding GNP figures.

A list of abbreviations and symbols used throughout this publication is included in Appendix 4.

COMPARABILITY WITH OTHER DONOR COUNTRIES

Statistics in this publication are expressed in Australian dollars and reported on an Australian financial year (July to June) basis. This may restrict, in some instances, a direct comparison between Australia's development cooperation and that of other donor countries.

Australia reports its development cooperation to the DAC in United States dollars on a calendar year basis to facilitate comparability between donor countries. This includes statistical information at the activity level, which can be accessed through the DAC's web site at http://www.oecd.org/dac.

COMPARABILITY WITH OTHER AUSAID PUBLICATIONS

The methodology for compiling statistical information differs in some instances between this and other AusAID publications, including the Aid Budget Statement, *Australia's International Development Cooperation* 2004-05, and Annual Report.

At a macro level, or total ODA, the data in AusAID's publications match. Due to some divergence in compilation methods and the classification of some activities there are differences at the detailed level. This publication also includes statistics on OA whereas other AusAID publications report on ODA only.

SOURCES OF DATA

The statistical information in this publication is primarily sourced from AusAID databases and is based on data extracted in September 2004. Additional information is sourced from OGDs, NGOs and volunteer agencies. Any revisions made to historical data after September 2004 will be reflected in future publications.

Statistical information on other donor countries' development assistance is sourced from the DAC.

REPORT LAYOUT

The tables in this publication are divided into four sections and followed by a set of explanatory and technical notes in Appendices 1 to 5.

Section one provides time series tables covering financial years, 2001-2002 to 2003-2004, and includes details of Australia's development cooperation by program element, partner country and sector.

Section two presents more detailed information on Australia's development cooperation with partner countries in the 2003-2004 financial year.

Section three provides supplementary information on various aspects of Australia's development cooperation, including through NGOs and multilateral organisations, and destinations of Australia's humanitarian, emergency and food aid.

Section four provides an overview of all DAC donor countries' development assistance.

Key statistics for 2003–2004

AUSTRALIA'S OFFICIAL DEVELOPMENT ASSISTANCE (ODA) TOTALLED \$1,973M IN 2003—2004, MORE THAN \$142M ABOVE 2002—2003. THIS REPRESENTED A REAL INCREASE OF 4.2 PER CENT. THE RATIO OF AUSTRALIA'S ODA TO GNI WAS 0.25 PER CENT.

GEOGRAPHIC FOCUS

Australia's development cooperation continued to focus on the Asia-Pacific region. The breakdown was **PNG and Pacific** (\$623m), **East Asia** (\$484m), **South Asia** (\$110m), **Sub-Saharan Africa** (\$73m) and **North Africa and Middle East** (\$68m).

HUMANITARIAN

Australia's humanitarian, emergency and refugee assistance program totalled **\$155m**. The top five partner country recipients were **Iraq** (\$38m), **Afghanistan** (\$18m), **Sri Lanka** (\$12m), **Indonesia** (\$11m), and **Sudan** (\$8m).

SECTORAL FOCUS

The major sectors benefiting from Australia's development cooperation were **government and civil society** (\$359m), **health** (\$176m), **agriculture**, **forestry and fishing** (\$157m), **education** (\$133m) and **transport and storage** (\$126m).

PARTNER COUNTRIES

The top five partner country recipients of Australia's ODA were **Papua New Guinea** (\$321m), **Indonesia** (\$159m), **Solomon Islands** (\$140m), **Vietnam** (\$74m) and **China** (\$54m).

31 per cent of Australia's allocable ODA went to **Least Developed Countries** (LDCs).

MULTILATERAL & NGO FLOWS

The top 5 multilateral recipients were the **World Bank** (\$171m), **Asian Development Bank** (\$113m), **World Food Program** (\$63m), **UNICEF** (\$41m) and **World Health Organisation** (\$24m).

Australia's development cooperation channelled through NGOs and volunteer sending agencies totalled **\$119m**.











DIAGRAM 6.1: PAPUA NEW GUINEA, 2003-2004




DIAGRAM 6.2: INDONESIA, 2003-2004




DIAGRAM 6.3: SOLOMON ISLANDS, 2003-2004




DIAGRAM 6.4: VIETNAM, 2003-2004




DIAGRAM 6.5: CHINA, 2003-2004




DIAGRAM 6.6: PHILIPPINES, 2003-2004




DIAGRAM 6.7: EAST TIMOR, 2003-2004




DIAGRAM 6.8: IRAQ, 2003-2004




DIAGRAM 6.9: CAMBODIA, 2003–2004





DIAGRAM 6.10: BANGLADESH, 2003–2004







Appendix 2: Concepts and definitions

Accountable Cash Grants: for activities involving the acquitable payment of grants directly to partner governments.

Accrual Accounting: the Australian Government moved to an accrual accounting framework in 1999-2000.

Cash and Expenses: some data is adjusted from an expense to cash basis. Adjustments are required for multi-year liabilities such as commitments to the Asian Development Fund and International Development Association. Adjustments exclude the expense commitments, which are recorded at the time of signing the Instrument of Commitments, and include the cash paid to those commitments. Adjustments are also made for items such as movements in creditors and depreciation.

Co-financing: activities involving co-funding with external organisations such as the World Bank, the Asian Development Bank and the United Nations Development Program (UNDP).

Commodity Assistance Program (CASP): provides grants to purchase and import Australian goods for developmental purposes. The scheme operates in African and Pacific Island countries.

Constant Prices: prices expressed in terms of the value of a chosen base year. Constant prices eliminate the effect of inflation on a series of figures, making them directly comparable.

Core and Non-core Contributions: Core contributions to multilateral organisations are pooled contributions and become an integral part of that organisation's financial assets whereby the donor country effectively loses control of the disposal of funds. Non-core contributions are those where the donor country specifies the recipient and other aspects of the disbursement of funds.

Country Program: covers development cooperation administered by AusAID in countries with which Australia has a development partnership.

Cross Regional Program: development cooperation administered by AusAID for the benefit of one or more

regions of the world. The relevant expenditures are allocated to the countries of flow where identifiable.

Current Prices: express value in terms of the value in the year of expenditure. (they record expenditure without any adjustment for inflation).

Departmental Expenditure: include salaries, equipment costs, rent and other running expenses of AusAID and other official bodies in administering international development cooperation.

Development Assistance Committee (DAC): a committee of the Organisation for Economic Cooperation and Development (OECD) and a key forum of major bilateral donors. The key activities of the DAC are as follows:

- i. adopts authoritative policy guidance for DAC Members;
- ii. conducts periodic reviews of its Members' programs;
- iii. provides a forum for dialogue, exchange and the building of international consensus on policy and management issues of interest to Members; and
- iv. publishes statistics and reports on aid and other resource flows to developing countries and countries in transition and related matters, based principally on reporting by Members.

Direct Aid Program (DAP): funds disbursed at the discretion of the (Australian) Head of Mission for small-scale development activities. This program is a sub-set of the Cross Regional Program.

Expenses and Cash: some data is adjusted from an expense to cash basis. Adjustments are required for multi-year liabilities such as commitments to the Asian Development Fund and International Development Association. Adjustments exclude the expense commitments, which are recorded at the time of signing the Instrument of Commitments, and include the cash paid to those commitments. Adjustments are also made for items such as movements in creditors and depreciation

Form of Aid: includes bilateral projects, staffing assistance, co-financing, bilateral food aid (except emergency food), the Commodities Assistance Program (CASP), accountable cash grants, training and other support.

Global Program: development cooperation administered by AusAID on a worldwide basis, as opposed to a country-specific or regional-specific basis. It includes contributions to international organisations, emergency, humanitarian and refugee programs (including emergency food aid), contributions to non-Government organisations (NGOs) and volunteer programs, development education and public information, development research, and the International Seminar Support Scheme (ISSS).

Gross National Income (GNI): income that accrues to those persons, enterprises and other organisations that are regarded as residents of a country. GNI equals gross domestic product plus residents' income from overseas property or productive activity less income transferred overseas. Under the new international System of National Accounts (SNA93) adopted by the Australian Bureau of Statistics (ABS), the actual measure used for comparative purposes is Gross National Income (GNI). This figure is similar, though not identical, to Gross National Product (GNP). Historical GNP figures throughout this publication have been revised to reflect the shift to GNI.

Implicit Price Deflator: provides an indication of the overall movement in the price of goods and services produced in Australia, whether used for domestic consumption or for exports. It is usually provided as an index figure for each financial year against a base year. The non-farm implicit price deflator applies to Australia's international development cooperation. It is provided by the Australian Bureau of Statistics and rebased every year.

Multilateral Flows: resources channelled via international organisations active in development such as the World Bank, the Asian Development Bank, UN Development Program (UNDP), UN Children's Fund (UNICEF) and World Food Program.

Non-AusAID Expenditure: covers development cooperation administered by the Australian Centre for International Agricultural Research (ACIAR) and other Australian Commonwealth and State Government departments.

Non-Government Organisation (NGO): a voluntary, notfor-profit community organisation, which undertakes international development cooperation and/or development education. Official Aid (OA): consists of flows that meet all the tests of ODA (see below), except that they are directed to countries on Part II of the DAC List of Aid Recipients (see Appendix 2) and to multilateral institutions which primarily benefit Part II aid recipients.

Official Development Assistance (ODA): defined as those flows to countries on Part I of the DAC List of Aid Recipients (see Appendix 2) and to multilateral institutions for flows to Part I aid recipients which are:

- i. provided by official agencies, including state and local governments, or by their executive agencies; and
- ii. each transaction of which:
 - a) is administered with the promotion of the economic development and welfare of developing countries as its main objective; and
 - b) is concessional in character and conveys a grant element of at least 25 per cent (calculated at a rate of discount of 10 per cent).

Some contributions are only partially reportable as ODA. Examples include contributions to the following UN organisations (with ODA eligible component expressed as a percentage):

Other Official Flows (OOF): official sector transactions to aid-eligible recipients which do not meet the ODA/OA criteria, eg:

- i. grants to aid recipients for representational or essentially commercial purposes;
- ii. official bilateral transactions intended to promote development but having a grant element of less than 25 per cent;
- iii. official bilateral transactions, whatever their grant element, that are primarily export-facilitating in purpose.
 This category includes by definition export credits extended directly to an aid recipient by an official agency or institution ("official direct export credits");
- iv. the net acquisition by governments and central monetary institutions of securities issued by multilateral development banks at market terms;
- v. subsidies (grants) to the private sector to soften its credits to aid recipients; and
- vi. funds in support of private investment.

Policy and Management Reform (PMR): the PMR initiative helps Pacific Island governments implement essential

economic and public sector management reforms. The focus is on increasing the efficiency and accountability of government, and on helping with the development of appropriate policy frameworks for natural resource management, foreign trade and investment and the domestic private sector. Funds are allocated competitively between countries on the basis of demonstrated commitment to reform and are additional to bilateral programs.

Projects: defined sets of activities which have identifiable objectives, outputs, time frames and implementation plans. Projects may be funded on a single year or multi-year time bases.

Program Support Unit (PSU): PSUs are established in AusAID's overseas posts and play a key role in the delivery of in-country development cooperation activities.

Regional Programs: development cooperation administered by AusAID to benefit countries in a specific geographic region. Expenditure is allocated to countries of flow where identifiable.

Small Activities Scheme: activities evaluated and funded that are short term and of small value.

Technical Cooperation (TC): the provision of specialist assistance in the form of personnel, training, research and associated costs. TC can be classified as investment-related or free-standing.
