Exchange of Letters No.1: Strengthening Capacity of the Fiji School of Medicine under the FSMed Strategic Plan 2008-12

This letter and its annexes initiate Exchange of Letters No.1 under Paragraph 6.3 of the Memorandum of Understanding between the Government of Australia and the Fiji School of Medicine (FSMed) 2007 - 2008.

2. The Government of Australia proposes to provide the Fiji School of Medicine with funding as set out in Annex B of this Exchange of Letters (EoL) for the mutually determined Focus Areas as set out in Annex A and outputs specified in Annex C.
3. The Terms and Conditions of the MoU under which this EoL is initiated shall survive the expiration of the MoU unless the MoU is replaced by a new arrangement under which this EoL ought reasonably sit.

5. Changes to this EoL may be made in writing by a Letter of Variation bearing both parties' signature.


