#### WHEREAS:

- A. On **7 April 2008** the Commonwealth and the Organisation entered into **Funding Agreement 44912** in writing for the provision of the Activity described in the Agreement.
- B. The Parties have now agreed to alter the Funding Agreement as set out herein.

#### **NOW THEREFORE THIS DEED WITNESSETH** as follows:

- 1. In this Deed unless the contrary intention appears, a reference to the "Agreement" is to the Agreement referred to in Recital A.
- 2. Subject to Clause 3 herein the Agreement is amended as set out below:

Clause 4.2	Delete existing Clause 4.2 and replace with new Clause 4.2 as follows:
	4.2 The Organisation must commence the Initiative on the date of its acceptance of this Agreement ("Initiative Start Date") and conclude the Initiative by <b>31 December 2011</b> .

3. In all other respects the parties confirm the Agreement.
