### GENERAL DESCRIPTION OF TASK(S) AND OBJECTIVES TO BE ACHIEVED

The Independent Evaluation Consultant shall operate under the overall supervision and responsibility of the Chief, Animal Health Service (AGAH), the general technical supervision of the Emergency Centre for Transboundary Animal Diseases (ECTAD) Regional Manager based in the Regional Office for Asia and the Pacific (RAP) and the operational supervision of the Chief, Emergency Operations Service (TCES).

The incumbent will be under the direct technical supervision of the team leader of the FAO Emergency Centre for Transboundary Animal Diseases (ECTAD) Programme in Myanmar, the general operational and administrative supervision of the FAO Representative and in close collaboration with the national veterinary authorities.

The incumbent will perform the following duties:

- Perform an evaluation of the animal health sector part of Phase II of the project OSRO/MYA/601/AUL, and in so doing be guided by relevant AusAID documents: the Standard Evaluation Questions, (registered document #153): and the instruction "How Do I Manage the Independent Evaluation of an Aid Activity?" (registered #151)
- Complete an evaluation report utilising the Independent Completion Report template (#155)
- Review all relevant reports from the project and documents including project design, progress reports, consultant reports, and reports of Letters of Agreement
- Meet and discuss with AusAID staff in Yangon
- Meet and discuss with relevant stakeholders in Yangon, Nay Pyi Taw and in the field where required. Stakeholders
  including FAO and WHO project staff, staff of the LBVD including senior staff, staff of the epidemiology and laboratory and
  field staff involved in project activities, relevant staff of the Department of Health, and Myanmar Livestock Federation, and
  poultry farmers.

# Project Evaluation on Prevention and Control of Avian and Human Pandemic Influenza

# Background and rationale

Myanmar has experienced 5 waves of Avian Influenza outbreaks in poultry since February/March 2006 to February/ March 2011 with only and one laboratory confirmed human case in November 2007. In 2009, H1N1 outbreaks occurred in Myanmar till 2010.

With the support of donors, such as USAID, AusAID, EC and others, the surveillance, outbreak investigation and response activities have been strengthened; Rapid Response Teams at state/region level and district levels were established and trained. To strengthen epidemiology, Field Epidemiology Trainings were conducted 4 times for medical officers and paramedics working at disease control area. For in country diagnosis of influenza sub-type, National Influenza Centre has been established and accredited since 2008. Since the sentinel surveillance of circulation influenza viruses and seasonal influenza is on going process. The surveillance officers and laboratory staff at sentinel sites have been trained on specimen collection, storage and forwarding.

For good management of the cases, 24 hospitals at border and high risk areas were supported with critical life saving ICU equipments, and isolation wards of key 12 hospitals were renovated. 50 medical officers at state/region level were trained on infection control management. Then, 337 hospital staff from district and township hospitals were also trained. In order to complete all the proposed activities to donor, the joint evaluation of project activity together with animal sector, with FAO, Myanmar need to be implemented to see the gaps and effectiveness of the project. The evaluation will be done separately however the joint report will be submitted to donor as requested by AusAID. The professional international evaluation expert needs to be hired under APW contract to carry out the M&E in collaboration with FAO, Myanmar.
