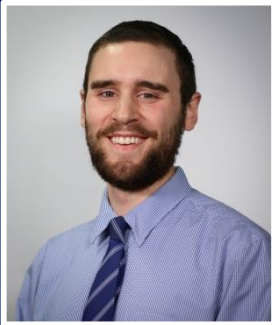
NCP HOST LOCATION: Fiji
