



Notification – Foreign diplomats – Quarantine

This form is used by the Department of Foreign Affairs and Trade to collect information about diplomats, consular officials and their dependants holding a diplomatic (subclass 995) visa to Australia for the purposes of arranging appropriate quarantine. Depending on the circumstances, this will be in government-designated hotel quarantine, at home or in private accommodation.
