Background

The overall goal of the Program is to enhance sustainable livelihoods of Samoan and improve their resilience to Climate Change impacts through better use of agricultural and forest resources, resulting also in mitigation of emissions and an improved economy. Its purpose is to improve the financial viability, resilience and sustainability of agroforestry and tree farming activities and associated industry. The Program has four (4) main components:

- 1. Agroforestry and Tree Farming Systems
- 2. Value Adding
- 3. Institutional Strengthening
- 4. Program Management

The problem to be addressed can therefore be summarized as follows. Samoa has a narrow economic base, which has been further aggravated by the depletion of forest resources, and the narrower the economic base, the more vulnerable the Samoan population and its economy are to climate change impacts.

The SATFP Program is for 5 years with a budget of AUD2.3 million or approximately SAT5 million.

Key Achievements

The achievements under the different outputs in the last six months are listed as follows

> Component 1: Agroforestry and Tree Farming Systems

- 1.1 Adequate quantities of high quality seedlings produced
- The five nurseries listed below were identified in the Program Design Document (PDD) which required extension and upgrading work. The Program provided support for other nurseries costs: polythene planting pots, soil collection, seeds and wildings collection.
- The completed nursery at STEC Land provides farmers with seedlings (forestry trees and other agriculture crops such as fruit trees and nonu).

1.2 More productive, diversified, and valuable farm forestry systems

The Program continued supporting the existing Community Forestry Program (CFP) within the Forestry Division-MNRE. The support is given to seedlings

production (**30,000 seedlings raised**), regular visit to existing farmers, liaison with communities and register of new farmers (**100+ registered farmers**) under the CFP.

- Two workshops conducted for farmers at Tuamasaga (Upolu) and Vaisigano (Savaii) Districts to promote Agroforestry Farming System. The two workshops were attended by 70 farmers. The feedback from the Farmers was that they have now gained further knowledge and skills on planting new crops and new tree species.
- Four (4) vehicles procured under Program to support extension activities. Vehicles are distributed to various Forestry Stations to support the SATFP activities incorporated into Forestry Division Management Plan. Vehicle Number Plates and Stations are as follow: MNRE 32-Maota, MNRE 47-Asau, MNRE 46-Vailima and MNRE 52-SATFP Program (Main Office). The vehicles have provided the Forestry officers with transport to hold site visits with farmers and transport seedlings from various nurseries.
- 1.3 More productive, diversified, and high value permaculture farming systems
- METI has been given AUD30,000 (50% of its annual budget) to support Permaculture and the Taiala Program which involved more than 164 farmers at different villages around the country. Progress Report submitted with acquittal of funds.
- Through the SATFP program, METI has been able to deliver further training and transfer of skills to their existing and new farmers.
- Ministry of Agriculture is working with SATFP Program to identify appropriate crops could be used for the program based on their existing programs and crop species are promoted.

> Component 2: Value adding

2.4 Private sector development funding for value adding provided

- Discussions with the Ministry of Finance and AusAID regarding funds of (AUD250,000) to support Private Sector and under this component will be merged with the amounts allocated (AUD200,000) for NGOs/CBOs under Component 1 (1.3.2) and be channelled through the established Private Sector Support Facility (PSSF) under the Ministry of Commerce Industry and Labour (MCIL). In total, the allocation for PSSF purposes is AUD450,000 over 5 years.
- Discussions with MCIL to transfer funds across will take place within the next month or two.

Component 3: Institutional Strengthening

3.4 Training Program Implemented

 Correspondence has been made with The Regional Forestry Community Training Centre RECOFTC and they are still keen to carry out the recommended training program as identified in the Program Design Document (PDD). However, expression of interest will be also invited from other institutions/organisations that can deliver and implement the recommended Training Program.

- Local counterpart with the assistance of her team will work to develop awareness materials required under this program to maximize public awareness. These materials are proposed to launch and publish during commemoration of the Ministry's National Events. This includes commemoration of World Wetland Day on February, World Biodiversity Day on May, World Water Day on March and Environment Week on November.

Issues and Challenges

a) Governance

Technical Adviser: The position of Technical Adviser was advertised in the local newspaper. Four applications were received and all were shortlisted. The preferred consultant accepted the TA position but later withdrew due to a misunderstanding in his contractual terms and conditions. The program is still without a Technical Adviser and is considering either to readvertise the position or to go with the next scored applicant.

Monitoring and Evaluation Consultant: Term of Reference for the Monitoring and Evaluation Consultant is in draft form and will be finalised once the Program Steering Committee approves

SATFP Program Coordinator: Recruitment of SATFP Program Coordinator (PC) to replace the former PC is now in progress.

- None
- c) Sustainability
- The sustainability of the SATFP Program rests on the MNRE especially the Forestry Division (FD). FD will have to make sure that Forestry Principal Officers serve as local counterparts and be fully involved in the implementation of the program. These local counterparts will work closely with the Program Coordinator and make sure the SATFP activities are incorporated in the Forestry Management Plan.
- d) Gender Equality
- The majority of farmers registered under the Community Forestry Program, and those involved in Permaculture farming comprised of 80% male and 20% female.

Risk Management

The project acknowledges the presence of the following risks and identified actions to address these risks.

• Achievements of deliverables within program timeframe

There is a risk of not being able to achieve all the outcomes of the Program within the set timeframe. To address this risk, the program has to procure and hire all the recommended consultants within Year 2 of the program to provide the required services.

The program has to form a Technical Team to identify issues that might affect progress and address them. The program technical team will comprise of MNRE, MAF, MCIL, MWCSD and NGOs.
