In Relation to cooperation between the Australian Sports Commission and AusAID in the delivery of the AUSTRALIAN SPORTS OUTREACH PROGRAM

This Schedule 1 sets out the shared goals of AusAID and the Australian Sports Commission (the **Parties**) in relation to the AUSTRALIAN SPORTS OUTREACH PROGRAM (the **Program**) which will be implemented under the Record of Understanding signed by the Parties on **11 August 2006** (**ROU**). This Schedule (including any Attachments) itemises the scope of the Program, contributions of each Party to the Program and sets out the accountability obligations of each Party, including the means for monitoring and evaluation. Unless otherwise stated in this Schedule, the terms and conditions of the ROU will apply. Detailed designs and work plans, including goals/objectives, outputs, monitoring/evaluation and risk assessments will be developed for each project / activity implemented as part of this Program.

AUSTRALIAN SPORTS OUTREACH PROGRAM

S1 COMMENCEMENT AND COMPLETION DATES

S1.1 The Program commenced on 1 July 2006 and will be completed by 30 June 2011.

S2 PROGRAM GOAL

- S2.1 AusAID and the ASC have collaborated to develop the document, Sport For Development A Strategy for the Australian Sports Outreach Program (the **Strategy**) refer Attachment 2. The Strategy will guide activities through to July 2011.
- S2.2 The goal level objective for the Program is to achieve, in the regions targeted:
 - Increased capacity to deliver inclusive sports based programs that contribute to social development.
- S2.3 The sports activities that are undertaken under the Program will be independently designed and will have this goal as their highest level objective. Each activity will have its own lower level objectives specific to the outcome being sought, with related outputs necessary to deliver that outcome.
- S2.4 Each sports based activity will:
 - include capacity building plans agreed with committed local partners;
 - promote sustained increases in sport related participation; and
 - contribute to one or more of improved leadership, health promotion, social cohesion, or the achievement of public diplomacy outcomes.

S3 PROGRAM DESCRIPTION

- S3.1 **Annual Budget**: A\$2,000,000, including A\$150,000 Post Discretionary Fund.
- S3.2 **Participating Countries:** The Program is comprised of three components the Pacific, Southern Africa and Targeted Activities.

The breakdown of annual funding is:

Pacific Component: minimum A\$1,000,000. This Component will be delivered regionally by the ASC in accordance with the management structure included in the Strategy. It will be delivered in conjunction with in-country partner organisations. Focus countries are Kiribati, Nauru, Samoa and Vanuatu.

The ASC and AusAID have also agreed to continue some activities that commenced under previous arrangements. These are Pacific Sport Ability (disability sport) in Fiji, Fiafia Sport (junior sport) in Samoa which will be absorbed into the country plan, production of Pacific Junior Sport resources and a review of Pacific Sport Ability resources.

Southern Africa Component: A\$400,000. This component will be delivered by the ASC in accordance with the management structure included in the Strategy. This Component, focussed on the Active Community Clubs (ACC) concept, will be delivered principally by locally engaged contractors who have been responsible for the successful development and implementation of the ACC concept in South Africa so far.

A detailed design review of the ACC will be undertaken immediately.

- Targeted Activities Component: A\$600,000. This component consists of:
 - A Small Grants Program implemented and managed by the ASC under the guidance of a project submission evaluation committee comprising representatives from the ASC and DFAT. In consultation with predominantly developing Commonwealth countries, activities that address locally identified needs will be supported. Activities undertaken must be identified through a structured project submission process.
 - The Post Discretionary Fund will be managed under this component, with operational responsibility residing with the Department of Foreign Affairs and Trade. In the first year funding for the Post Discretionary Fund will come out of the Pacific Component. The ASC will look to cover the Post Discretionary Fund from the Targeted Activities Component in subsequent years as the Program is bedded in.
 - Activities in the Caribbean undertaken through the in-country delivery partner, the Trinidad and Tobago Alliance for Sport and Physical Education, have been rolled into this component. These activities will be transitioned into the structured submission process in parallel with a focus on sustainability.
- S3.3 Detailed design and planning of activities will be in accordance with the Strategy.

S4 FINANCIAL ARRANGEMENTS

- S4.1 The financial arrangements outlined below will apply to the Program.
- S4.2 The maximum **annual** amount payable by AusAID in respect of the Program is **A\$2,000,000** plus GST if any, to a maximum amount over the life of the Program of **A\$10,000,000** plus GST. AusAID will not be liable for any amount, costs or expenditure incurred by the ASC in excess of this amount.
- S4.3 AusAID will pay the ASC the sums in accordance with the budgets and timetable set out below within 30 days of endorsing ASC six-monthly reports. Reports will be endorsed within 21 days of receipt, unless agreed substantive issues remain outstanding.
- S4.4 ASC six-monthly reports will be presented to AusAID in a jointly agreed format (see Attachment 1) in June and December of each year.
- S4.5 As part of its six-monthly reporting obligations, the ASC will submit a statement acquitting funds advanced for the previous six-monthly period and a budget

outlining expenditure for the subsequent six-monthly period. Each report will clearly show funds expended and funds committed. Any uncommitted funds may be carried over into the next financial year. Unexpended or uncommitted advances remaining at the conclusion of the final year, if any, will be refunded to AusAID together with the final acquittal statement, or as otherwise agreed at any time by the Parties in writing.

A\$173,178 represents the amount underspent by the ASC and DFAT under the Australia-South Pacific Sports Program 2006. DFAT currently holds this amount and payments from the ASC to DFAT for the Post Discretionary Fund will be reduced accordingly. It was agreed that a further \$25,000 be retained by AusAID to meet the costs associated with AusAID's participation in design related missions in the 2006/07 financial year.
