**THIS DEED OF AMENDMENT** is made this 22 day of DECEMBER 2010

**BETWEEN:**

The **COMMONWEALTH OF AUSTRALIA**, represented by the **AUSTRALIAN AGENCY FOR INTERNATIONAL DEVELOPMENT, ABN 62 921 558 838** ("the Commonwealth") of the one part

**AND**

**UNIVERSITY OF MELBOURNE**, through the Department of Paediatrics, International Child Health Unit ("CICH") **ABN 84 002 705 224**; **THE MACFARLANE BURNET INSTITUTE FOR MEDICAL RESEARCH AND PUBLIC HEALTH LTD ("BURNET") ABN 49 007 349 984**; and **MENZIES SCHOOL OF HEALTH RESEARCH ("MENZIES") ABN 70 413 542 847**, jointly called the WCH Organisations (the "Organisations").

**WHEREAS:**

- A. On **7 April 2008** the Commonwealth and the Organisations entered into **Funding Agreement 44748** (also known as 44902) in writing for the provision of the Activity described in the Agreement.
- B. The Parties have now agreed to alter the Funding Agreement as set out herein.

**NOW THEREFORE THIS DEED WITNESSETH** as follows:

- 1. In this Deed unless the contrary intention appears, a reference to the "Agreement" is to the Agreement referred to in Recital A.
- 2. Subject to Clause 3 herein the Agreement is amended as set out below:

Clause 1.2	Delete existing Clause 1.2 and replace with new Clause 1.2 as follows:  “ 1.2 The implementation period commencing in 1 January 2009 and ending 31 December 2011”.
Clause 2.1.c	Delete existing Clause 2.1.c and replace with new Clause 2.1.c as follows:  “ c) one (1) month prior to the end of the Agreement between AusAID and the WCH Organisations, a final report.”


Clause 2.2 Final Report	Delete Final Report paragraph in Clause 2.2 and replace with a new paragraph as follows:  <u>“Final Report</u>  The Final Report, submitted as per Clause 2.1.c above, must contain ...”
Clause 5.2	Delete existing Clause 5.2 and replace with new Clause 5.2 as follows:  “ 5.2 The WCH Organisations must commence the WCH Hub Initiative on <b>7 April 2008</b> and conclude by <b>31 December 2011.</b> ”

3. The amendments set out in this Deed take effect on the date on which this Deed is signed by both parties.
4. In all other respects the parties confirm the Agreement.
